Preface

This monthly statistical release provides information on South African residents and foreign travellers who entered or left South Africa in August 2021. Specific focus is on foreign tourists who entered the country during this month. The tourists are classified by region and country of residence. Details of their mode of travel; purpose of visit; age and sex distribution are also provided.

1. Key findings

1.1 Travellers

1.1.1 Number of travellers

The routine data collected by the Department of Home Affairs' (DHA) immigration officers at the ports of entry into and out of South Africa shows that a total of 770 617 travellers (arrivals, departures and transits) passed through South African ports of entry/exit in August 2021. As presented in Table 1 on page 9, these travellers were made up of 260 662 South African residents and 509 955 foreign travellers. A further breakdown of the figures for South African residents indicates that there were 124 804 arrivals, 135 733 departures and 125 travellers in transit. The corresponding volume for foreign arrivals, departures and travellers in transit was 268 946, 228 828 and 12 181 respectively.

A comparison between the movements in August 2020 and August 2021 is not included as there was a hard lockdown in August 2020 and only essential services providers were allowed to travel.

A comparison between the movements in July 2021 and August 2021 indicates that the volume of arrivals, departures and transits increased for both South African residents and foreign travellers. For South African residents, the volume of arrivals increased by 16,1% (from 107 542 in July 2021 to 124 804 in August 2021), departures increased by 19,0% (from 114 044 in July 2021 to 135 733 in August 2021) and transits increased by 5,9% (from 118 in July 2021 to 125 in August 2021). For foreign travellers, arrivals increased by 23,7% (from 217 373 in July 2021 to 268 946 in August 2021), departures increased by 13,4% (from 201 821 in July 2021 to 228 828 in August 2021) and transits increased by 6,5% (from 11 439 in July 2021 to 12 181 in August 2021).

Detailed information on the departure of travellers is not available in the movement control system. Data on the purpose of travel and the number of days South African residents intend to spend or spent abroad are not collected by the DHA. It is therefore not possible to categorise South African residents as tourists or non-tourists. However, some data are available on foreign arrivals for this categorisation.

As presented in Table 1 on page 9, in August 2021, 45 917 (17,1%) of foreign arrivals were classified as non-visitors while 223 029 (82,9%) were classified as visitors. The visitors were categorised into three groups:

- i. Arrivals only comprising visitors who entered the country in August 2021 but did not depart in August 2021 [78 022 (35,0%)];
- ii. Single trips visitors who came to South Africa once in August 2021 and left in August 2021 [64 319 (28,8%)];
- iii. Multiple trips visitors who came to and left South Africa more than once in August 2021 [80 688 (36,2%)].

Visitors were further grouped as same-day visitors and overnight visitors (tourists). In August 2021, there were 37 392 (16,8%) same-day visitors and 185 637 (83,2%) tourists. Between July 2021 and August 2021, the volume of same-day visitors increased by 22,4% (from 30 538 in July 2021 to 37 392 in August 2021) and that of tourists increased by 22,7% (from 151 264 in July 2021 to 185 637 in August 2021).

1.1.2 Mode of travel of travellers

Information presented in Table 2 on page 10, shows the number of South African residents and foreign travellers by travel direction and mode of travel. In August 2021, road transport was the most common mode of travel used by 547 689 (71,1%) of the 770 617 travellers. The total number of travellers who used air transport was 216 132 (28,0%). Compared to air and land transport, a smaller number of travellers, 6 796 (0,9%) used sea transport into and out of South Africa. Information on arrivals of South African residents shows that 38 993 (31,2%) came by air, 85 673 (68,6%) came by road and 138 (0,1%) arrived by sea. For departures, 49 312 (36,3%) used air, 86 275 (63,6%) used road and 146 (0,1%) left by sea. All travellers in transit, 125 (100,0%) used air transport.

In the case of foreign travellers, 60 355 (22,4%) arrived by air, 205 433 (76,4%) came by road and 3 158 (1,2%) arrived by sea transport. When departing South Africa, 55 166 (24,1%) foreign travellers left by air, 170 308 (74,4%) left by road and 3 354 (1,5%) left by sea. All travellers in transit, 12 181 (100,0%) used air transport. Table 2 further shows that of the 37 392 same-day visitors, a majority, 31 128 (83,2%) arrived in the country by road, 6 257 (16,7%) flew into the country and seven (less than 0,1%) arrived by sea. Information on tourists shows that 140 386 (75,6%) used road transport, 45 228 (24,4%) came by air transport and 23 (less than 0,1%) arrived by sea transport.

1.2 Tourists

1.2.1 Mode of travel of tourists

The country of residence of tourists is used to categorise them according to their respective countries and regions. Information on the specific region and country of residence of tourists and the mode of travel used to enter South Africa is provided in Table 3 on pages 11 to 14. In August 2021, 25 860 (91,8%) of the 28 157 overseas tourists arrived in the country by air transport, whilst 2 274 (8,1%) came in by road transport and 23 (0,1%) arrived by sea. Tourists from the Southern African Development Community (SADC) countries, on the other hand, came predominantly by road, 137 656 (89,7%) and 15 863 (10,3%) came by air. The number of tourists who came into South Africa by air from 'other' African countries was 3 310 (91,5%) and 308 (8,5%) used road transport.

1.2.2 Regional and national distribution

In August 2021, the distribution of overseas tourists was as follows: Europe, 12 586 (44,7%); North America, 9 387 (33,3%); Asia, 3 701 (13,1%); The Middle East, 1 371 (4,9%); Central and South America, 851 (3,0%) and Australasia, 261 (0,9%).

Figure 1 on page 7 indicates that the ten leading overseas countries in terms of the number of tourists visiting South Africa in August 2021 were: United States of America (USA), 8 808 (31,3%); United Kingdom (UK), 2 025 (7,2%); Germany, 2 008 (7,1%); France, 1 729 (6,1%); India, 1 613 (5,7%); The Netherlands, 1 231 (4,4%); Spain, 806 (2,9%); Saudi Arabia, 765 (2,7%); Italy, 594 (2,1%) and Canada, 579 (2,1%). Tourists from these ten countries constituted 71,6 % of all tourists from overseas countries.




Figure 2 - Number of tourists from the ten leading Southern African Development Community (SADC) countries in August 2021

Virtually, most tourists from Africa, 153 519 (97,7%), came from SADC countries. The distribution of the remaining tourists from Africa is as follows: East and Central Africa, 1 691 (1,1%); West Africa, 1 548 (1,0%) and North Africa 379 (0,2%). Ten leading SADC countries in terms of the number of tourists visiting South Africa in August 2021 were: Mozambique 46 568 (30,3%); Zimbabwe, 30 981 (20,2%); Lesotho, 29 388 (19,1%); Eswatini, 16 365 (10,7%); Botswana, 8 844 (5,8%); Namibia, 7 561 (4,9%); Zambia, 5 825 (3,8%); Malawi, 4 986 (3,2%); Tanzania, 1 138 (0,7%) and Democratic Republic of Congo (DRC), 941 (0,6%) (see Figure 2 on page 7). Tourists from these ten countries constituted 99,4% of all tourists from the SADC countries.





Figure 3 – Number of tourists from the ten leading 'other' African countries in August 2021

The ten leading countries in terms of the number of tourists visiting South Africa in August 2021 from 'other' African countries, as shown in Figure 3 on page 8, were: Nigeria, 758 (21,0%); Kenya, 588 (16,3%); Ghana, 503 (13,9%); Uganda 273 (7,5%); Gabon, 255 (7,0%); Ethiopia, 200 (5,5%); Cameroon, 182 (5,0%); Egypt, 176 (4,9%); Congo, 108 (3,0%) and The Sudan, 72 (2,0%). Tourists from these ten countries constituted 86,1% of all tourists from 'other' African countries.

1.2.3 Purpose of visit

Table 4 on pages 15 to 18, shows the number of tourist by country of residence and purpose of visit. It is observed that in August 2021, the majority of tourists, 168 075 (90,5%), were in South Africa for holiday¹ compared to 13 692 (7,4%); 3 515 (1,9%) and 355 (0,2%) who were in South Africa for business, study and for medical treatment respectively.

Within the overseas regions, North America had the highest proportion of its tourists who came for holiday, 98,2% (9 220) followed by Australasia, 95,0% (248); Central and South America, 94,4% (803); The Middle East, 94,1% (1 290); Europe, 93,0% (11 706) and Asia, 93,0% (3 442).

Asia, 4,1% (152) had the highest proportion of its tourists who came to South Africa for business, followed by Europe, 2,3% (292); Central and South America, 2,2% (19); Australasia, 1,1% (3); North America, 0,7% (68) and The Middle East, 0,6% (8).

The Middle East, 5,3% (73) had the highest proportion of tourists who came to study, followed by Europe, 4,4% (552); Australasia, 3,4% (9); Central and South America, 3,2% (27); Asia, 2,5% (92) and North America, 1,0% (92).

Asia had 0,4% (15) of its tourists who came for medical treatment, followed by Australasia, 0,4% (1); Europe, 0,3% (36); Central and South America, 0,2% (2) and North America, 0,1% (7). The Middle East had no tourists who came to South Africa for medical treatment.

The majority of African tourists, 141 034 (89,8%) came to South Africa for holiday. However, the following differences in terms of reasons for travel were observed between tourists from the SADC countries and 'other' African countries, namely:

- Holiday makers constituted 89,8% (137 891) of tourists from SADC countries compared to 86,9% (3 143) from 'other' African countries. Information on the regions of 'other' African countries shows that 91,2% (1 412) of tourists from West Africa were on holiday, followed by tourists from East and Central Africa, 85,0% (1 437) and North Africa 77,6% (294).
- Business persons constituted 8,5% (13 063) of tourists from SADC countries compared to 2,2% (81) from 'other' African countries. North Africa, 3,7% (14) had the highest proportion of its tourists who came to South Africa for business purposes, followed by East and Central Africa, 3,0% (50) and West Africa, 1,1% (17).
- Students constituted 9,8% (355) of tourists from 'other' African countries compared with 1,5% (2 314) from SADC countries. North Africa, 18,2% (69) had the highest proportion of its tourists who came to South Africa for study purposes, followed by East and Central Africa, 10,3% (175) and West Africa, 7,2% (111).
- Medical treatment tourists constituted 1,1% (39) of tourists from 'other' African countries, while those from SADC constituted 0,2% (251) of its tourists. East and Central Africa, 1,7% (29) had the highest proportion of its tourists who came for medical treatment, followed by North Africa, 0,5% (2) and West Africa, 0,5% (8).

1.2.4 Sex and age distribution

Table 5 on page 19, shows the number of tourists by country of residence, sex and age group. There were 127 250 (68,5%) male and 58 387 (31,5%) female tourists. Overseas tourists were made up of 16 627 (59,1%) male tourists and 11 530 (40,9%) female tourists. There were 108 152 (70,4%) male and 45 367 (29,6%) female tourists from SADC countries. Tourists from 'other' African countries were made up of 2 264 (62,6%) male and 1 354 (37,4%) female tourists.

The ages of tourists were categorised into seven broad groups (see Table 5 for a detailed classification). The results presented in Table 5 further show that the majority of tourists were aged between 35 and 44 years [63 176 (34,0%)]. Taking the regions of residence into consideration, the results show that the highest proportion of tourists from 'other' African countries [1 037 (28,7%)] and those from overseas countries [5 506 (19,6%)] were aged between 25 and 34 years, whereas those from SADC countries [56 917 (37,1%)] were aged between 35 and 44 years.

¹ The holiday category includes tourists who came for vacation, visiting friends and relatives, shopping and other personal reasons. See section 5.5.2 on page 25 for a more detailed discussion.

The second highest proportion of tourists from 'other' African countries [1 028 (28,4%)] and those from overseas countries [5 119 (18,2%)] were aged between 35 and 44 years, whereas those from SADC countries [35 906 (23,4%)] were aged between 25 and 34 years. The median ages of tourists from overseas, SADC and 'other' African countries were 39, 39 and 34 years respectively. The proportion of tourists younger than 15 years was higher among tourists from overseas countries, 9,3% (2 625) followed by those from 'other' African countries, 8,9% (321) compared to those from SADC countries, 2,9% (4 518).

A comparison of the three regions shows higher proportions of the elderly (those aged 65+) among both male and female tourists from overseas. This comprised of 10,4% (1 722) males and 10,3% (1 187) females from overseas countries. However, tourists aged 65 years and older from the other two regions comprised of less than 3,5% of both male and female tourists: from SADC countries, elderly tourists were made up of 1,5% (1 645) males and 3,0% (1 367) females; while in 'other' African countries elderly tourists made up 1,5% (35) and 1,6% (21) of male and female tourists respectively.

Figure 1 - Number of tourists from the ten leading overseas countries in August 2021

5. Explanatory notes

5.1 Introduction

Legal movements across South African borders, as well as legal immigration into South Africa, fall under the jurisdiction of the Department of Home Affairs (DHA). Stats SA then processes, analyses and publishes this information.

Administrative data sources from the DHA, that is, information from all the country's ports of entry and applications for permanent residence, constitute the only comprehensive source of information on foreign arrivals and departures, documented immigrants and emigrants. The information from this source of data provides the best national coverage (both in terms of space and time) of the population movements of South African residents and foreign travellers. The data can be used for the following:

- To estimate, monitor and understand salient characteristics of foreign travellers and volumes of South African residents travelling outside South Africa.
- To provide information that can be used to (a) assess the extent of government's progress in strengthening bilateral political and economic relations by assessing the number of international tourist arrivals, and (b) benchmark surveys focusing on the demand for local tourism services by foreign travellers.

5.2 Purpose of the statistical release

This release reports on arrivals, departures and transit travellers of South African residents and foreign travellers. Detailed information on the age and sex distribution; mode of travel; national and regional distribution; and purpose of travel of overnight visitors or tourists are also provided.

5.3 Scope and coverage

The release covers data collected by DHA officials on travellers who departed from or entered the Republic of South Africa (RSA).

5.4 Data

Information published in this release is based on data obtained from the following data sources within the DHA:

- Data routinely collected by immigration officers at all road, air and sea entry ports on all travellers (South African residents and foreign travellers) arriving into or departing from South Africa are captured into the DHA's population Movement Control System (MCS). The counts/statistics relate to the number of individual movements, rather than to the number of people. Hence, the multiple movements of individual people during the calendar month are each counted separately. Generally, the data are collected directly from travel documents either by scanning or capturing onto the ports' electronic database. No forms or cards are used (except on rare occasions when the capturing system is down) to collect information from travellers. Individual ports regularly transmit data onto the national database at the head office of the DHA.
- Stats SA receives downloaded data covering a particular calendar month from the DHA.
- As part of data interrogation, data from O.R. Tambo International Airport, which has the highest volume of travellers, are compared with passenger statistics from the Airports Company of South Africa (ACSA). As expected, in any specific month, an increase in the volume of passengers reported by ACSA is also reflected in an increase in the volume of travellers recorded by DHA. A similar pattern has also been observed when the volume of travellers decreased. In August 2021, the DHA data was 2,8% higher than that of ACSA.

5.5 Limitations

5.5.1 Outbound tourists

The information on the total number of arrivals and departures of South African residents is collected from the scanning of passports. However, data on the country visited are not collected from passengers; country of final destination; intended duration of stay and purpose of visit. With this limitation, it is impossible to identify the number of tourists from the data on South African residents.

5.5.2 Purpose of visit

The holiday category includes tourists who came for vacation, visiting friends and relatives, shopping and other personal reasons such as attending weddings. While it's possible to separate 'visiting friends and relatives' from the broad category of Holiday, shopping and other reasons for visiting South Africa are all combined with vacation in the DHA movement control system. Discussions are in progress with the Department of Home Affairs to capture vacation and shopping as separate categories for a clearer breakdown of tourists by purpose of visit.

5.6 Definition of terms

5.6.1 Definitions used by the United Nations World Tourism Organisation (UNWTO)

Traveller is someone who moves between different geographical locations for any purpose and any duration.

Visitor refers to any person travelling to a place other than that of his/her usual environment for less than 12 months and whose main purpose of the trip is other than the exercise of an activity remunerated from within the place visited.

Same-Day visitor is a visitor who visits a place for less than one night.

Tourist (overnight visitor) is a visitor who stays at least one night in collective or private accommodation in the place visited.

Tourism comprises the activities of persons travelling to, and staying in places outside their usual environment, for not more than one consecutive year, for leisure, business and other purposes. The usual environment of a person consists of a certain area around his/her place of residence, plus all the other places he/she frequently visits.

5.6.2 Definitions used specifically in this release

South African resident refers to either a South African citizen or a non-South African citizen with a South African permanent residence permit.

Foreign traveller refers to a traveller who is not a South African citizen or permanent resident.

Region refers to the following country classification:

- Overseas: Europe, North America, Central and South America, Australasia, the Middle East and Asia.
- Africa: SADC and 'other' Africa (East and Central Africa, West Africa and North Africa).

Country refers to individual countries within a region. The country of residence is used. The country of residence should not be confused with the country from which the visitor travelled.

Africa refers to all the countries in Africa (both mainland and island countries).

SADC refers to the fourteen countries, excluding South Africa, which belong to the Southern African Development Community.

'Other' African refers to all non-SADC African countries.

Overseas refers to all countries outside Africa.

Trip refers to the arrival and departure of a visitor in a specified month.
