## Income at constant 2015 prices: results for February 2019

Measured in real terms (constant 2015 prices), total income generated by the food and beverages industry increased by 3,3% in February 2019 compared with February 2018. Food sales grew by 4,0% – see Table A.

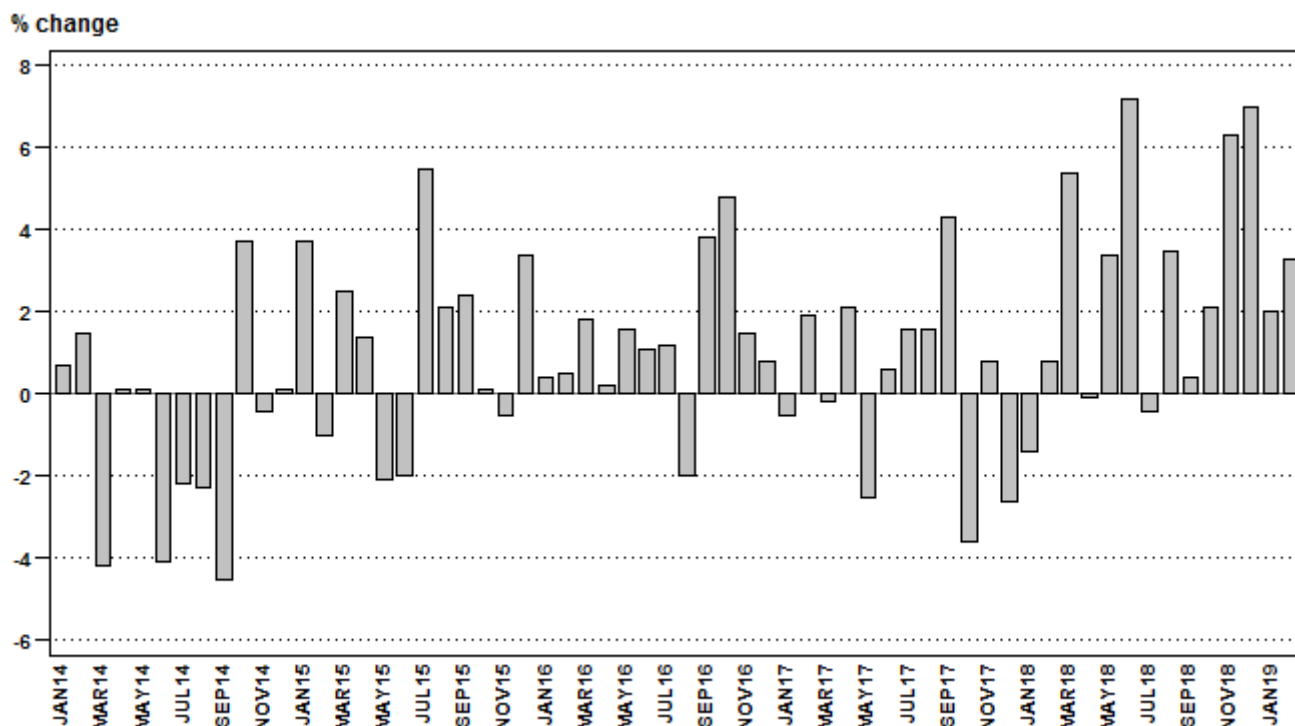
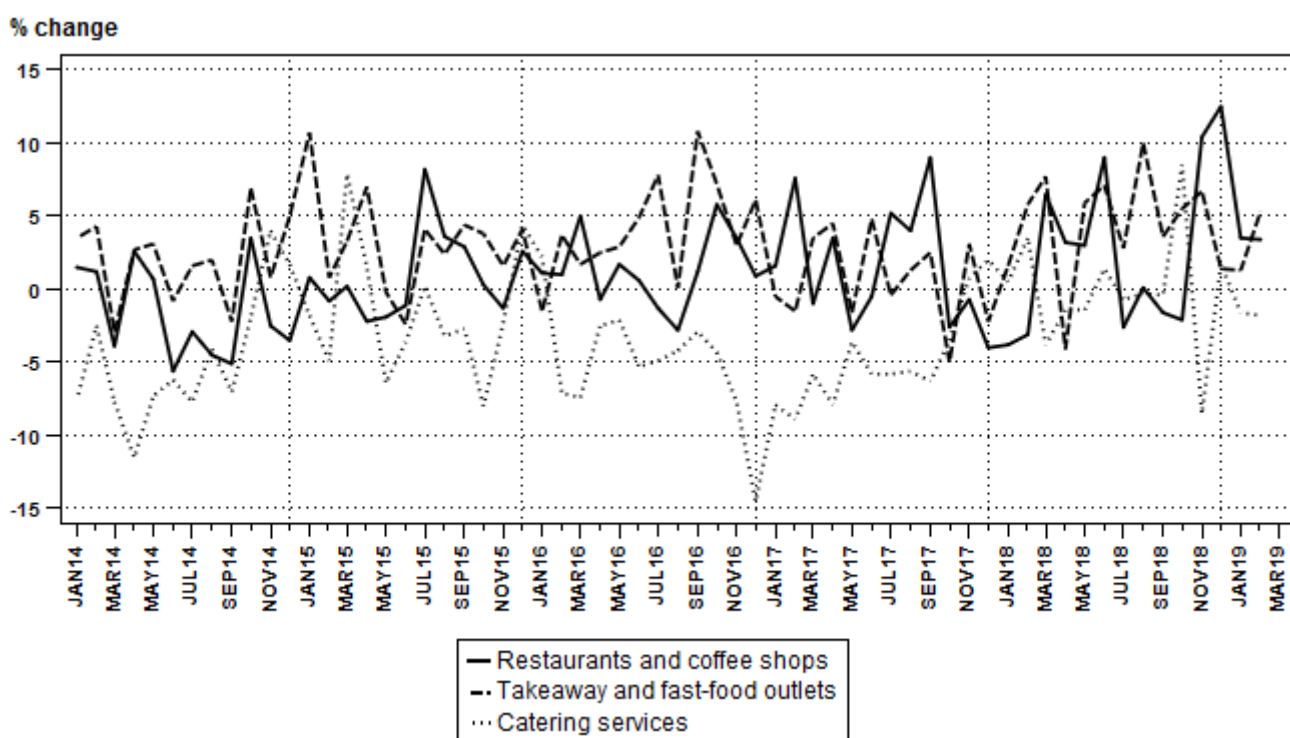
In February 2019, positive annual growth rates were recorded for:

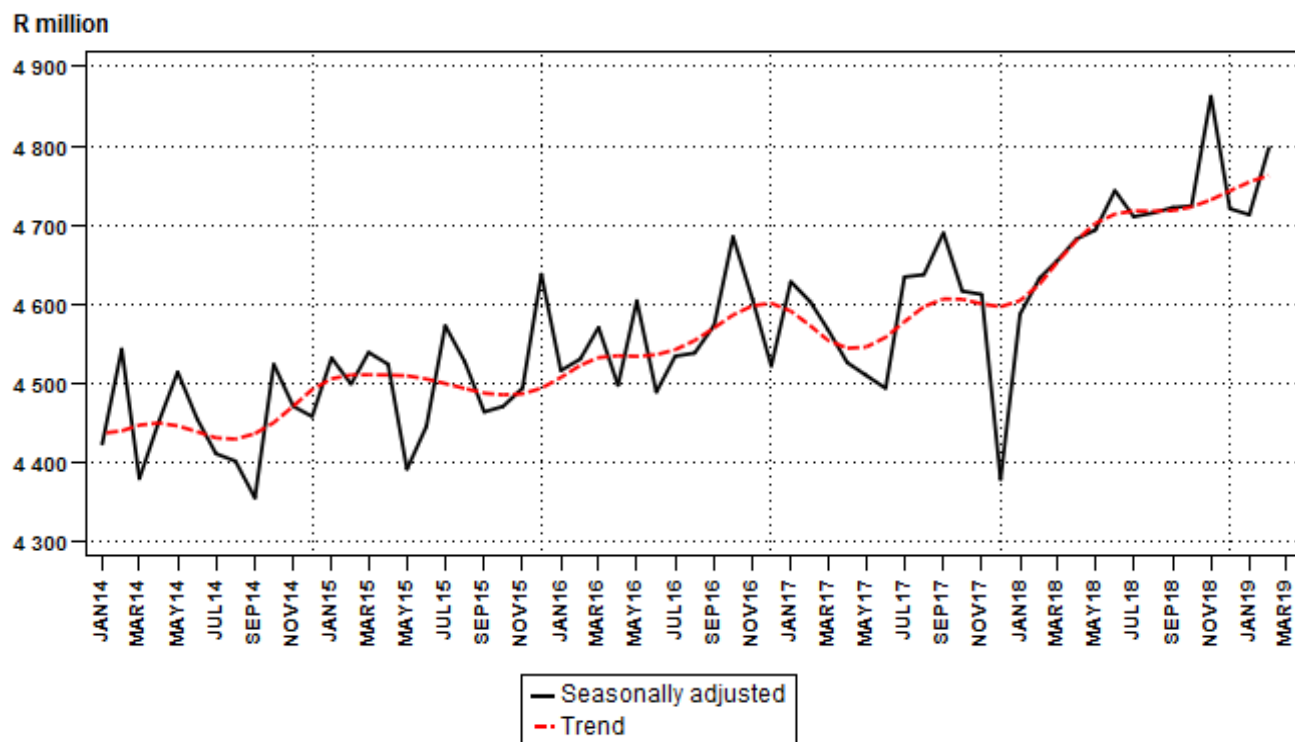
- takeaway and fast-food outlets (5,3% and contributing 1,8 percentage points); and
- restaurants and coffee shops (3,4% and contributing 1,7 percentage points) – see Tables B and 6.

Total income increased by 4,4% in the three months ended February 2019 compared with the three months ended February 2018. The main contributor to this increase was restaurants and coffee shops (6,9% and contributing 3,5 percentage points) – see Table C.

Seasonally adjusted food and beverages income increased by 1,8% month-on-month in February 2019. The largest month-on-month growth rates were recorded for:

- takeaway and fast-food outlets (2,9%); and
- restaurants and coffee shops (1,2%) – see Table 7.

**Class limits**

The enterprises are divided into four size groups according to turnover. Large enterprises are enterprises with an annual turnover of R32,5 million and more. The cut-off points which define the size groups, namely large, medium, small and very small enterprises are given in Table D.

**Sample weighting**

For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-collection in the survey. Stratum estimates are calculated and then aggregated with the completely enumerated stratum to form subgroup estimates. These procedures are in line with international best practice.

**Seasonal adjustment**

Seasonally adjusted estimates are generated each month using the X-12-ARIMA Seasonal Adjustment Program developed by the US Bureau of the Census. Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences on the series can be recognised more clearly. Seasonal adjustment does not aim to remove irregular or non-seasonal influences which may be present in any particular month. Influences that are volatile or unsystematic can still make it difficult to interpret the movement of the series even after adjustment for seasonal variations. Therefore the month-to-month movements of seasonally adjusted estimates may not be reliable indicators of trend behaviour. **Trend cycle**

The trend is the long-term pattern or movement of a time series. The X-12-ARIMA Seasonal Adjustment Program is used for smoothing seasonally adjusted estimates to estimates of the underlying trend cycle.

**Reliability of estimates**

Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is, it may differ from the figures that would have been produced if the data had been obtained from all enterprises in the food and beverages industry in South Africa.

**Relative standard error**

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate.

**Non-sampling errors**

Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.
