Measured in real terms (constant 2015 prices), total income generated by the food and beverages industry decreased by 42,5% in September 2020 compared with September 2019. The largest decreases were recorded for:

- bar sales (-65,6%); and
- food sales (-41,2%) – see Table A.

In September 2020, the main contributors to the 42,5% year-on-year decrease were:

- restaurants and coffee shops (-61,9% and contributing -32,3 percentage points); and
- catering services (-54,0% and contributing -8,2 percentage points) – see Tables B and 6.

Total income decreased by 45,8% in the third quarter of 2020 compared with the third quarter of 2019. The main contributors to this decrease were:

- restaurants and coffee shops (-65,3% and contributing -33,5 percentage points); and
- catering services (-60,6% and contributing -9,3 percentage points) – see Table C.

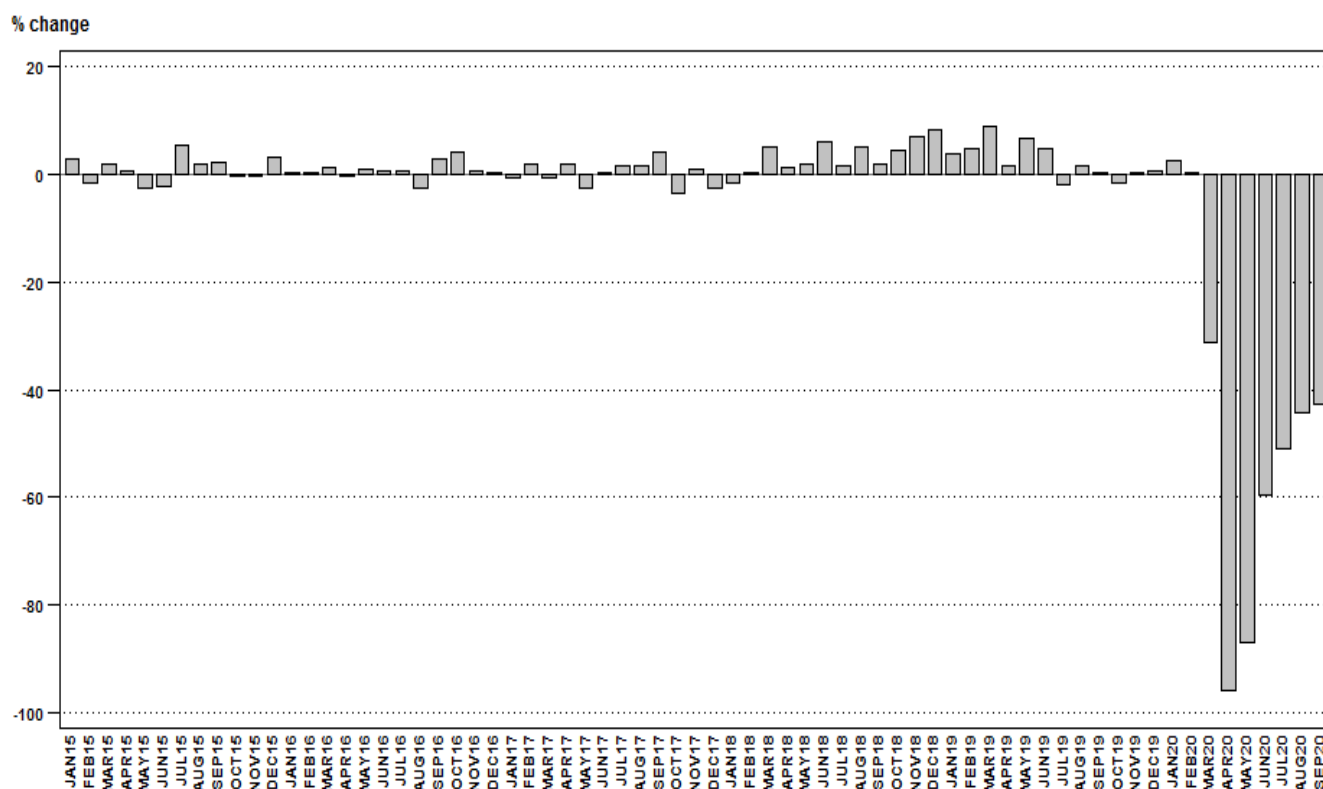
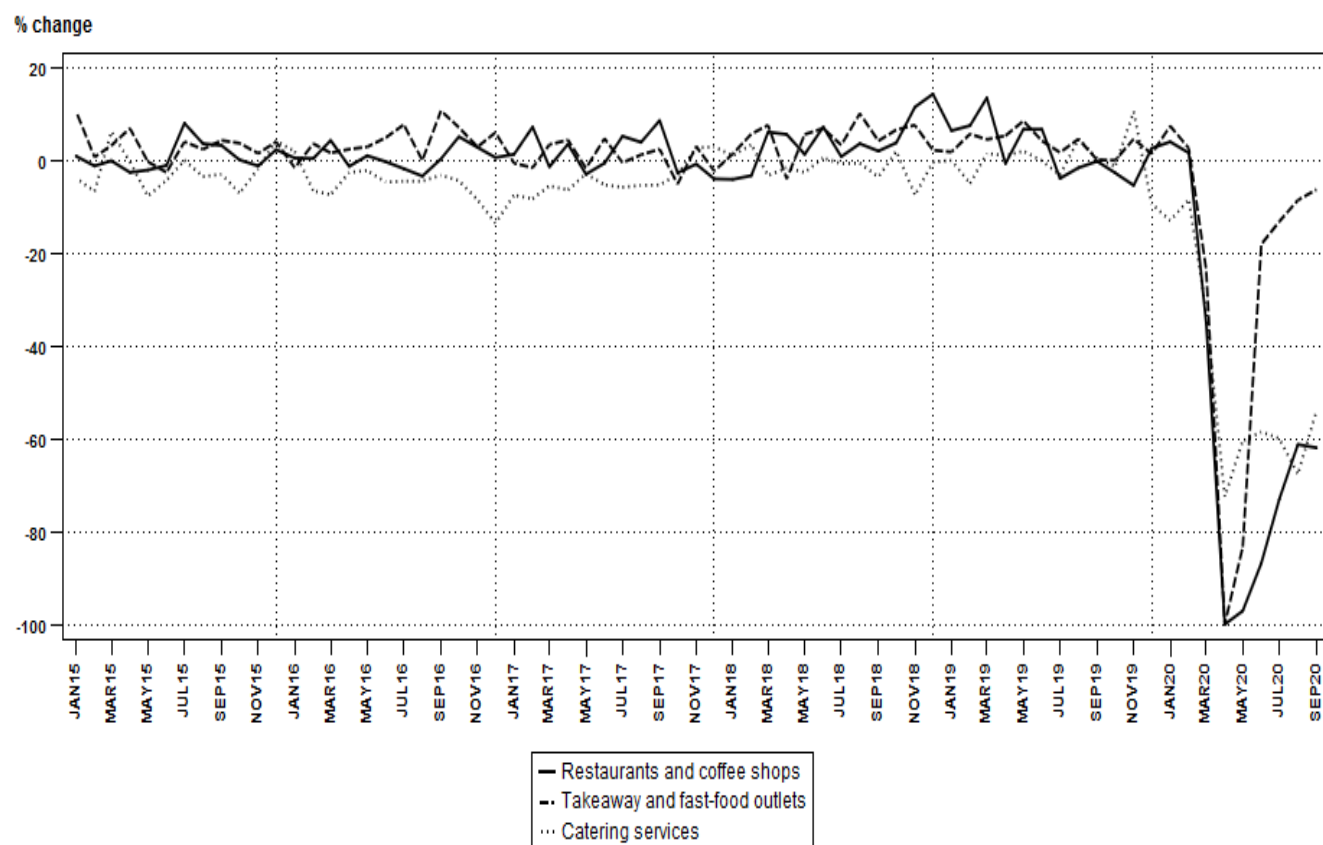
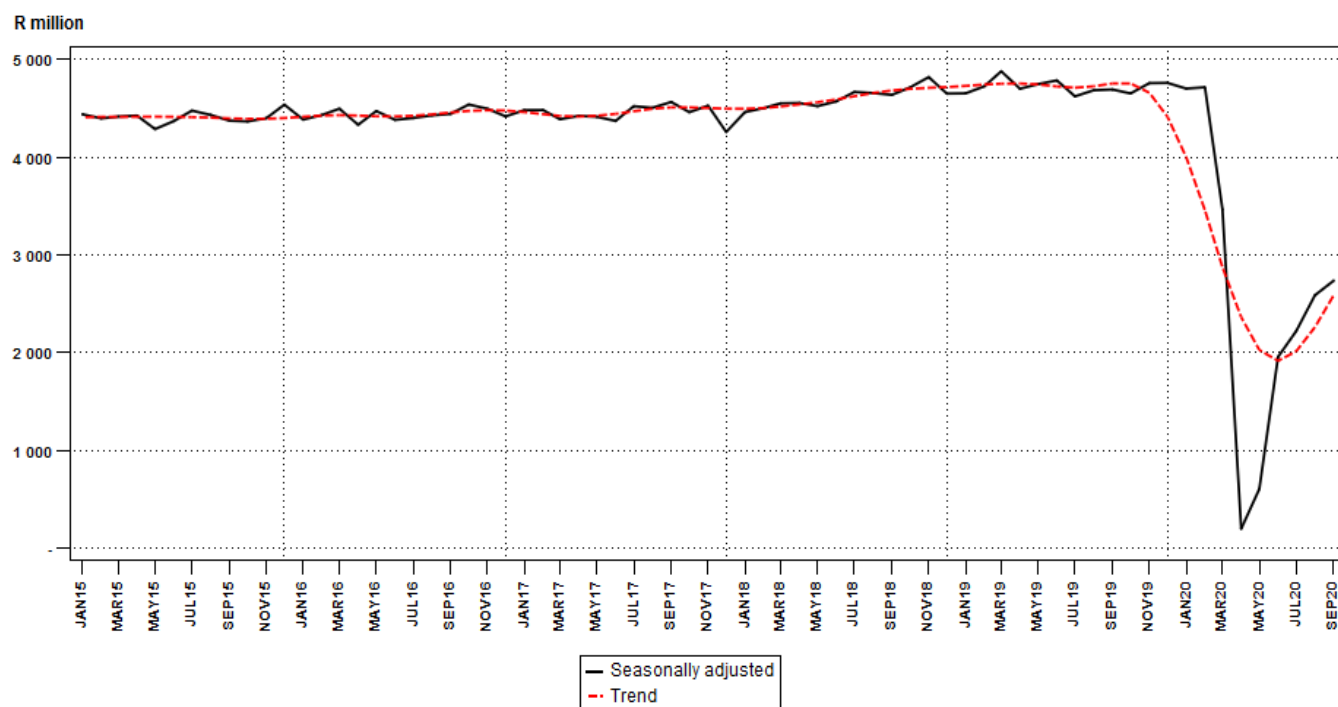
Figure 1 – Food and beverages income at constant 2015 prices: year-on-year percentage change**Figure 2 – Food and beverages income at constant 2015 prices: year-on-year percentage change by type of enterprise**

Seasonally adjusted food and beverages income increased by 5,8% in September 2020 compared with August 2020. This followed month-on-month changes of 16,5% in August 2020 and 13,5% in July 2020 – see Tables 3 and 7.

Survey information

Introduction	The results presented in this publication are derived from the monthly survey of the food and beverages industry. This survey is based on a sample drawn from the 2019 business sampling frame (BSF) that contains businesses registered for value added tax (VAT).
Purpose of the survey	The food and beverages survey is a monthly survey covering a sample of public and private enterprises involved in the preparation of meals and drinks for immediate consumption in South Africa. The purpose of this survey is to monitor trends in the food and beverages industry. The results of the food and beverage survey are used to compile estimates of the tourism satellite accounts (TSA) and the gross domestic product (GDP) and its components, which are used to develop and monitor government policy. These statistics are also used in the analysis of comparative business and industry performance.
Scope of the survey	This survey covers the following tax registered private and public enterprises, that are mainly engaged in providing food and beverages for immediate consumption: • restaurants and coffee shops; • takeaway and fast-food outlets; and • catering services.
Classification by industry	The 1993 edition of the <i>Standard Industrial Classification of all Economic Activities</i> (SIC), Fifth Edition, Report No. 09-90-02, was used to classify the statistical units in the survey. The SIC is based on the 1990 <i>International Standard Industrial Classification of all Economic Activities</i> (ISIC) with suitable adaptations for local conditions. Each enterprise is classified to an industry which reflects its predominant activity. Statistics in this publication are presented at 5-digit SIC level.
Collection rate	The preliminary collection rate for the survey on food and beverages for September 2020 was 81,0%. The improved collection rates for August and July 2020 were 83,1% and 84,1% respectively.
Statistical unit	The statistical unit for which information is compiled and published is an enterprise, defined as a legal unit or a combination of legal units that includes and directly controls all functions necessary to carry out its income activities. The statistical units are derived from and linked to the South African Revenue Service (SARS) administrative data.
Revised figures	Revised figures are mainly due to late submission of data to Stats SA, or respondents reporting revisions or corrections to their figures. Preliminary figures, as indicated in the relevant tables, are subject to change and when revised will not be indicated as such. Data are edited at the enterprise level.
Rounding-off of figures	Where figures have been rounded off, discrepancies may occur between sums of the component items and the totals.

Technical notes

Survey methodology and design	The survey was conducted by mail, fax and telephone. A sample of 1 118 enterprises was drawn from a population of 9 851 enterprises using stratified simple random sampling in April 2019. The enterprises were first stratified at 5-digit level according to the SIC and then by size of enterprises. Large enterprises are completely enumerated. Turnover was used as the measure of size.

Class limits

The enterprises are divided into four size groups according to turnover. Large enterprises are enterprises with an annual turnover of R32,5 million and more. The cut-off points which define the size groups, namely large, medium, small and very small enterprises are given in Table D.

Sample weighting

For those strata not completely enumerated, the weights to produce estimates are the inverse ratio of the sampling fraction, modified to take account of non-collection in the survey. Stratum estimates are calculated and then aggregated with the completely enumerated stratum to form subgroup estimates. These procedures are in line with international best practice.

Seasonal adjustment

Seasonally adjusted estimates are generated each month using the X-12-ARIMA Seasonal Adjustment Program developed by the US Bureau of the Census. Seasonal adjustment is a means of removing the estimated effects of normal seasonal variation from the series so that the effects of other influences on the series can be recognised more clearly. Seasonal adjustment does not aim to remove irregular or non-seasonal influences which may be present in any particular month. Influences that are volatile or unsystematic can still make it difficult to interpret the movement of the series even after adjustment for seasonal variations. Therefore the month-to-month movements of seasonally adjusted estimates may not be reliable indicators of trend behaviour. Note: Owing to the impact of the COVID-19 lockdown, additive outlier adjustments were performed. The methodology will be reviewed as more data points are added to the time series.

Trend cycle

The trend is the long-term pattern or movement of a time series. The X-12-ARIMA Seasonal Adjustment Program is used for smoothing seasonally adjusted estimates to estimates of the underlying trend cycle.

Reliability of estimates

Data presented in this publication are based on information obtained from a sample and are, therefore, subject to sampling variability; that is, it may differ from the figures that would have been produced if the data had been obtained from all enterprises in the food and beverages industry in South Africa.

Relative standard error

One measure of the likely difference is given by the standard error (SE), which indicates the extent to which an estimate might have varied by chance because only a sample of enterprises was used. The relative standard error (RSE) provides an immediate indication of the percentage errors likely to have occurred due to sampling, and thus avoids the need to refer to the size of the estimate.

Non-sampling errors

Inaccuracies may occur because of imperfections in reporting by enterprises and errors made in the collection and processing of the data. Inaccuracies of this kind are referred to as non-sampling errors. Every effort is made to minimise non-sampling errors by careful design of questionnaires, testing them in pilot studies, editing reported data and implementing efficient operating procedures. Non-sampling errors occur in both sample surveys and censuses.

Constant prices	Food and beverages income at constant prices by type of enterprise and by type of income is estimated by deflating income at current prices using the relevant components of the consumer price index for restaurants.	
Year-on-year percentage change	The year-on-year percentage change in a variable for any given period is the change between that period and the corresponding period of the previous year, expressed as a percentage of the latter.	
Contribution (percentage points)	The contribution (percentage points) to the annual percentage change for any given period is calculated by multiplying the percentage change of each type of enterprise by its corresponding weight, divided by 100. The weight is the percentage contribution of each type of enterprise to total income in the corresponding period of the previous year.
