Key findings for January 2021

Final manufactured goods – headline PPI

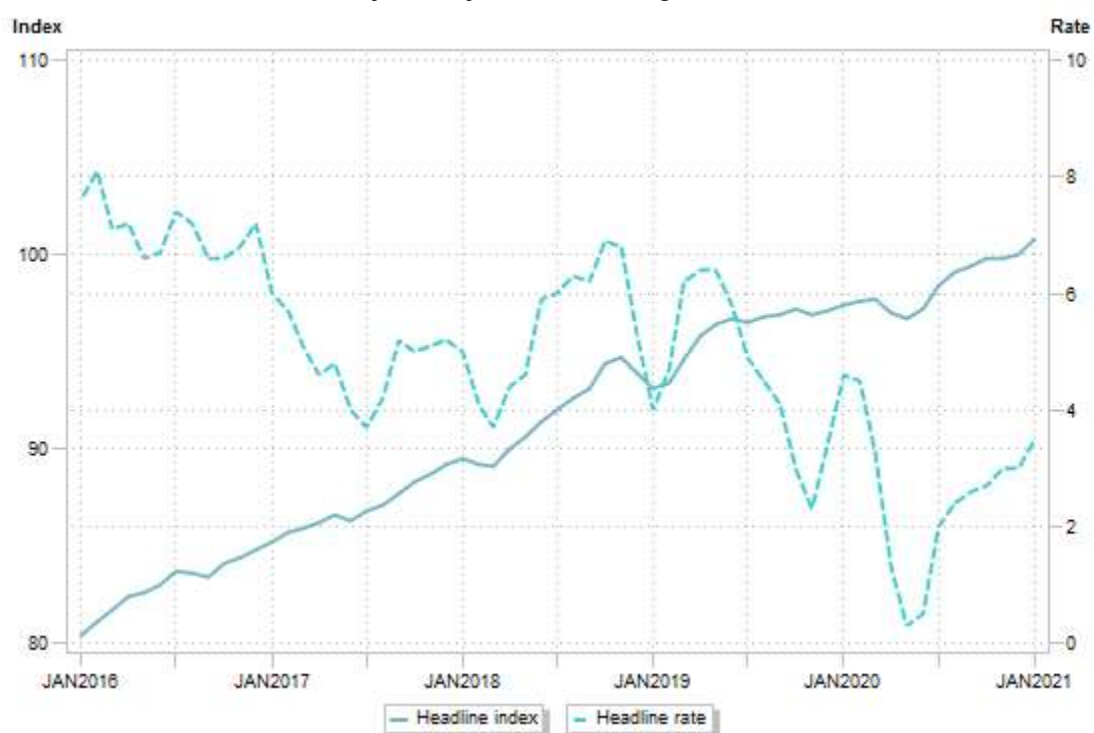
Annual producer price inflation (final manufacturing) was 3,5% in January 2021, up from 3,0% in December 2020. The producer price index increased by 0,8% month-on-month in January 2021.

The main contributors to the headline PPI annual inflation rate were food products, beverages and tobacco products; metals, machinery, equipment and computing equipment; and transport equipment (Figure 1.2 on page 7).

- Food products, beverages and tobacco products increased by 5,9% year-on-year and contributed 2,1 percentage points.
- Metals, machinery, equipment and computing equipment increased by 4,4% year-on-year and contributed 0,6 of a percentage point.
- Transport equipment increased by 6,5% year-on-year and contributed 0,6 of a percentage point.

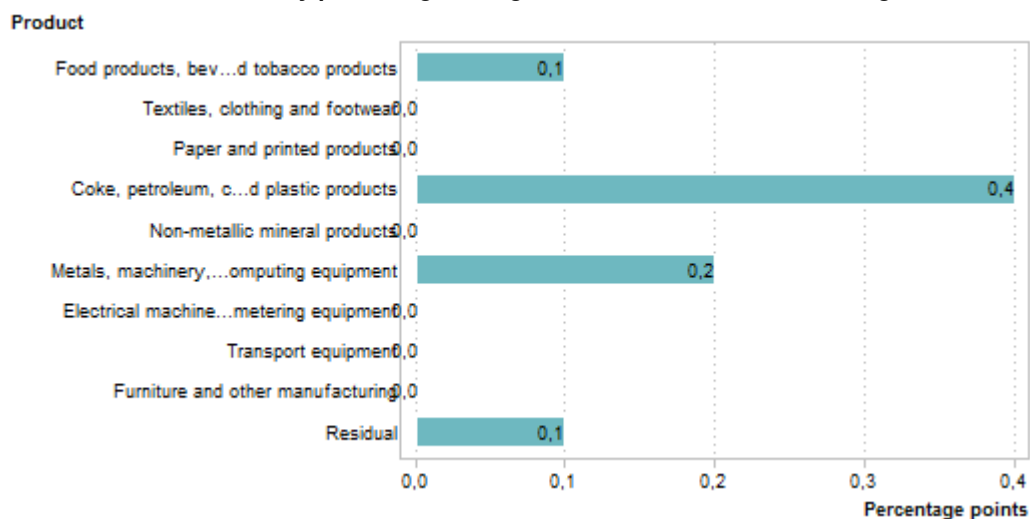
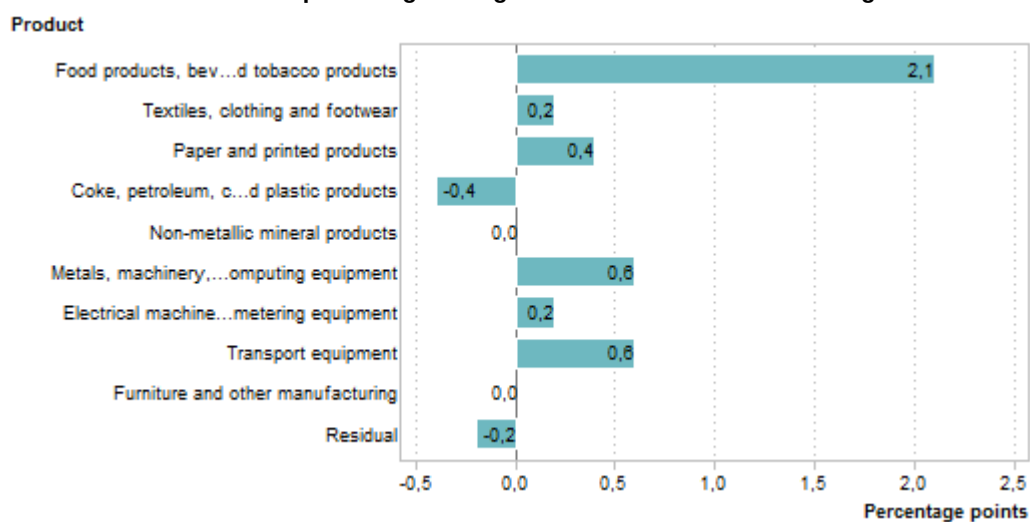
Figure 1.1 - Contributions to the monthly percentage change in PPI for final manufactured goods**Figure 1.2 - Contributions to the annual percentage change in PPI for final manufactured goods**

The main contributor to the headline PPI monthly increase was coke, petroleum, chemical, rubber and plastic products, which increased by 2,3% month-on-month and contributed 0,4 of a percentage point (Figure 1.1 on page 7).

Key findings for January 2021

Intermediate manufactured goods

The annual percentage change in the PPI for intermediate manufactured goods was 8,6% in January 2021 (compared with 6,8% in December 2020). The index increased by 2,4% month-on-month.

The main contributors to the annual rate were basic and fabricated metals (6,3 percentage points) and chemicals, rubber and plastic products (1,6 percentage points) (Figure 2.2).

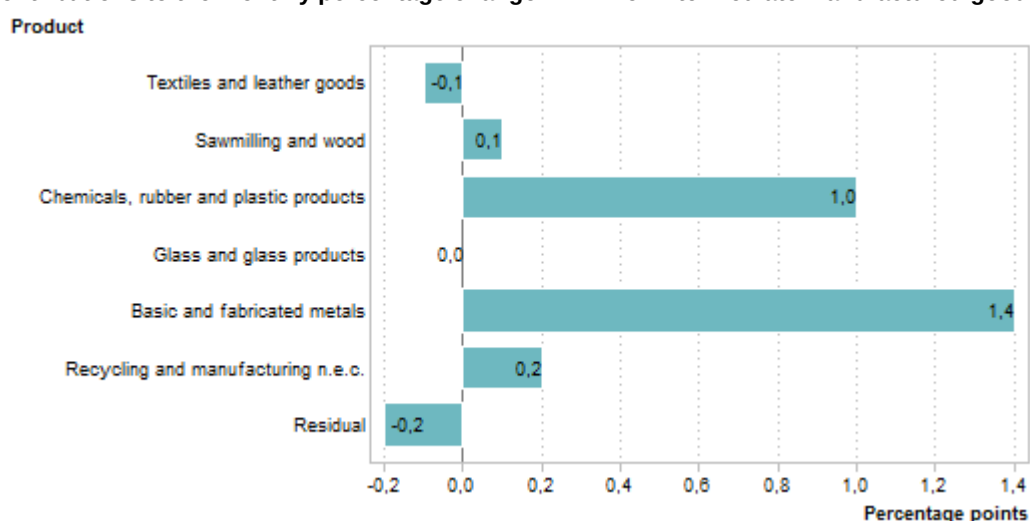
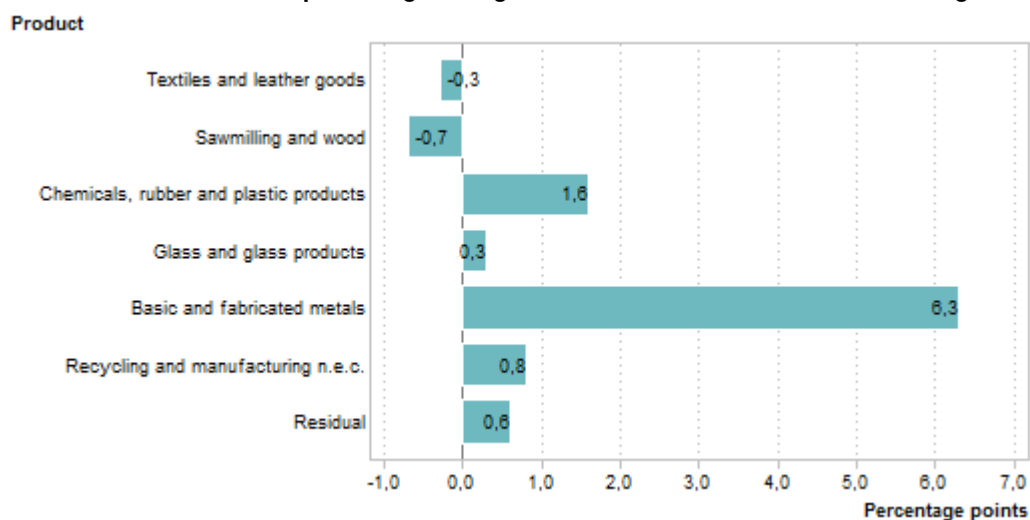
Figure 2.1 - Contributions to the monthly percentage change in PPI for intermediate manufactured goods**Figure 2.2 - Contributions to the annual percentage change in PPI for intermediate manufactured goods**

The main contributors to the monthly rate were basic and fabricated metals (1,4 percentage points) and chemicals, rubber and plastic products (1,0 percentage point) (Figure 2.1).

Electricity and water

The annual percentage change in the PPI for electricity and water was 8,7% in January 2021 (compared with 8,2% in December 2020). The index decreased by 1,1% month-on-month.

Electricity contributed 7,6 percentage points to the annual rate, and water contributed 1,0 percentage point (Figure 3.2).

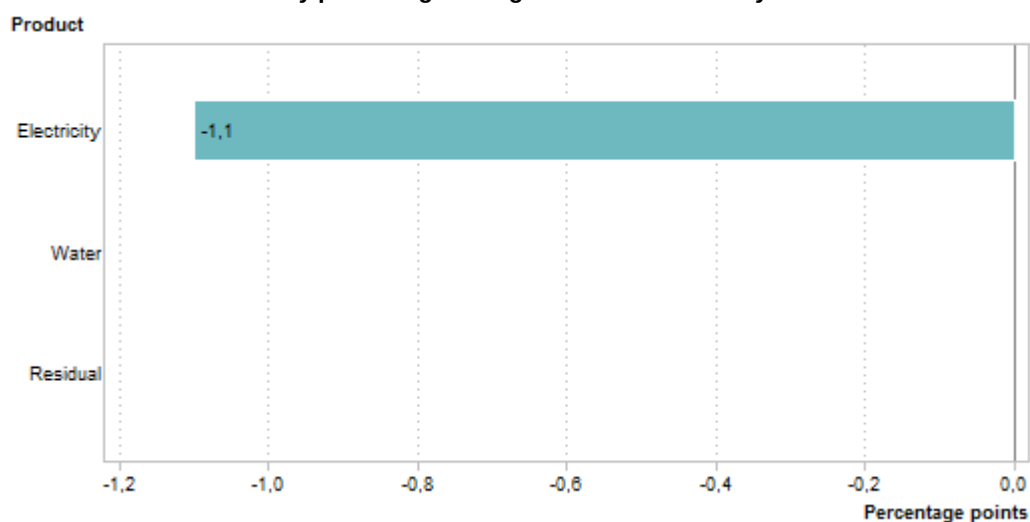
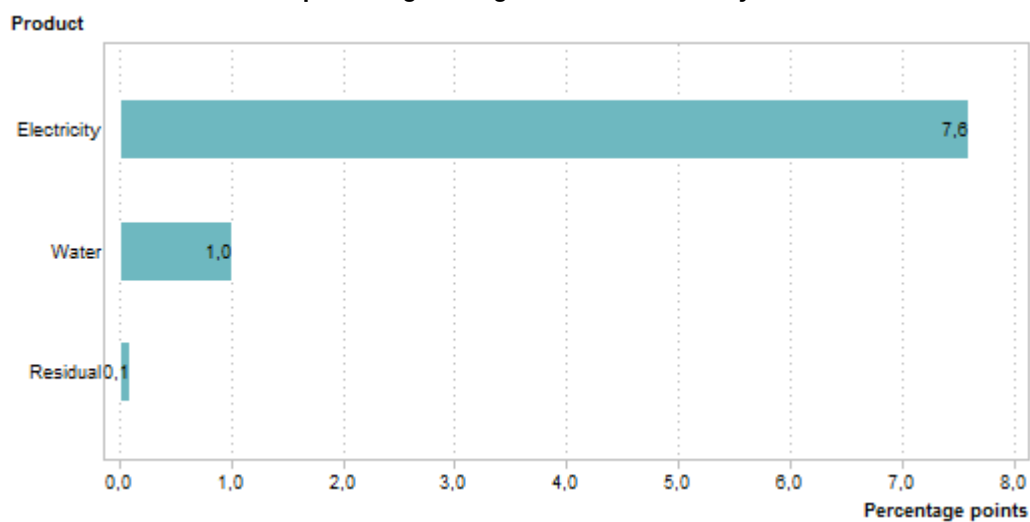
Figure 3.1 - Contributions to the monthly percentage change in PPI for electricity and water**Figure 3.2 - Contributions to the annual percentage change in PPI for electricity and water**

Electricity contributed -1,1 percentage points to the monthly rate (Figure 3.1).

Mining

The annual percentage change in the PPI for mining was 22,9% in January 2021 (compared with 25,3% in December 2020). The index increased by 4,3% month-on-month.

The main contributors to the annual rate were non-ferrous metal ores (10,4 percentage points) and gold and other metal ores (10,2 percentage points) (Figure 4.2).

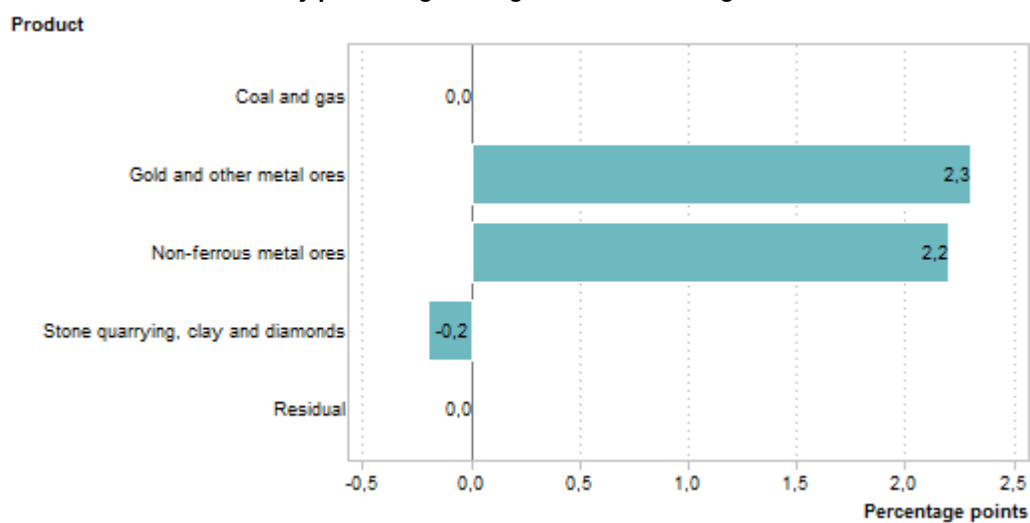
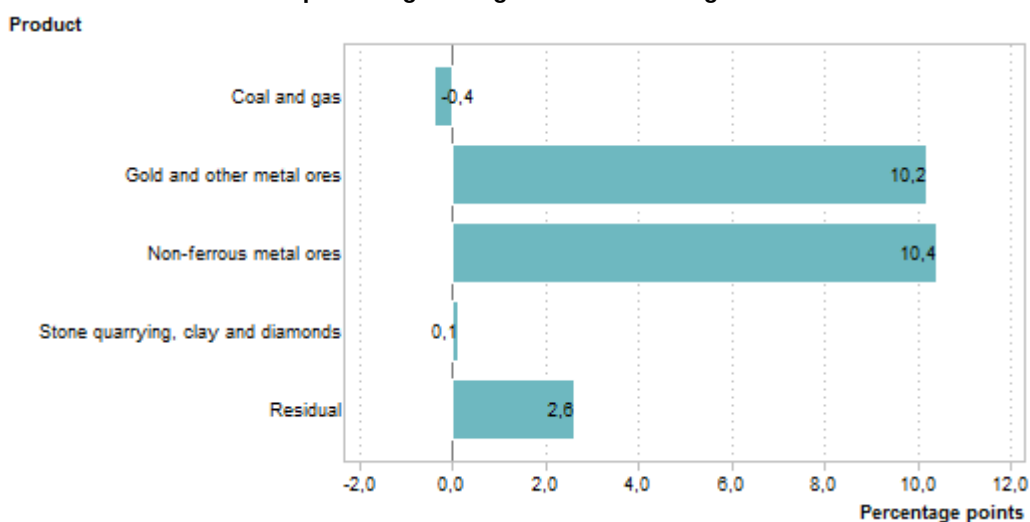
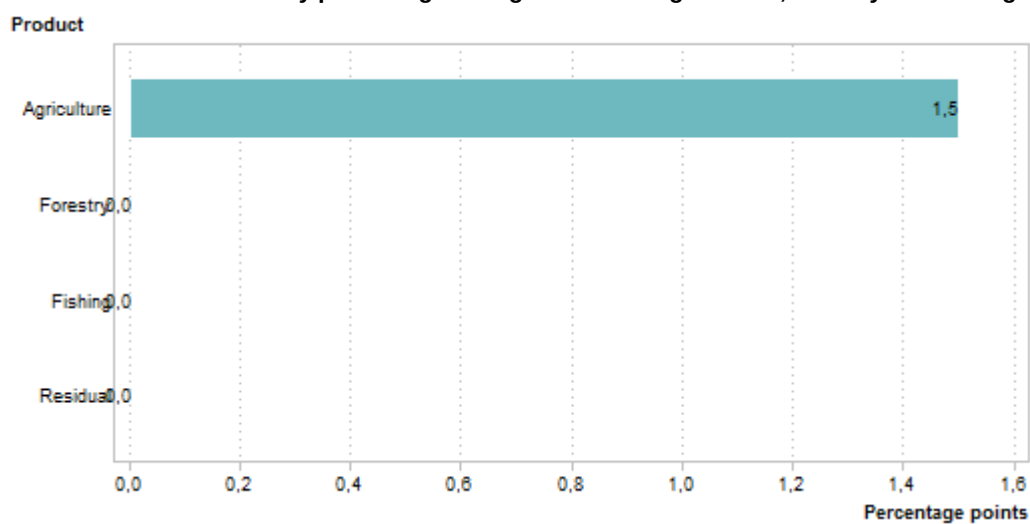
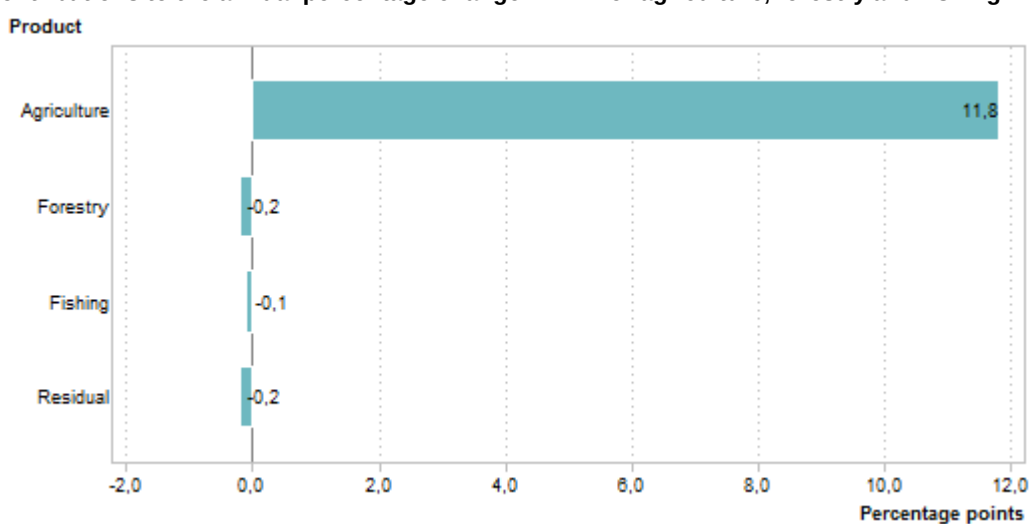
Figure 4.1 - Contributions to the monthly percentage change in PPI for mining**Figure 4.2 - Contributions to the annual percentage change in PPI for mining**

The main contributors to the monthly rate were gold and other metal ores (2,3 percentage points) and non-ferrous metal ores (2,2 percentage points) (Figure 4.1).

Agriculture, forestry and fishing

The annual percentage change in the PPI for agriculture, forestry and fishing was 11,3% in January 2021 (compared with 9,1% in December 2020). The index increased by 1,5% month-on-month.

The main contributor to the annual rate was agriculture (11,8 percentage points).

The contributor to the monthly rate was agriculture (1,5 percentage points).

Reweightings and rebasing of the producer price index

The producer price indices (PPIs) for January 2021 reflect updates to the basket and weights, and were rebased to December 2020 = 100.

Industry-level weights are updated each year based on the value added of each sector to the overall economy as recorded in the GDP. Product weights for industries other than manufacturing are updated each year based on sales data sourced through government departments and industry bodies.

Weights for products which serve either as an input to manufacturing processes (intermediate manufactured goods), or as a final output (final manufactured goods), are based on Stats SA's large sample survey of the manufacturing industry. The most recent survey was published in 2019 and covers the financial years of producers ending between July 2016 and June 2017.

Explanatory notes

Purpose and results of the survey	The Producer Price Index (PPI) measures changes in the prices of locally produced commodities. A sample of producers is surveyed each month and the results of this survey are used to compile the producer price indices for final manufactured goods, intermediate manufactured goods, electricity and water, mining, and agriculture, forestry and fishing. The PPI can be used as an economic indicator of inflation, as an escalator in contracts and as a deflator in the calculation of the national accounts. Further information on the weighting structure, sources of information and methods of compilation of the PPI can be found in the PPI sources and methods document, available on the Stats SA website.

Glossary

Producer Price Index	The PPI is defined as “A measure of the change in the prices of goods either as they leave their place of production or as they enter the production process (OECD).”
Contributions	The monthly (annual) contribution of a specific product or group of products to the specific PPI is calculated by multiplying the weight of this product or group of products with the difference of the current index and the previous month (year) index for this product or group of products, divided by the index for the specific index, for the previous month (year).
Annual inflation rate	The annual inflation rate per specific PPI is the change in the specific PPI for all items of the relevant month of the current year compared with the specific PPI for all items of the same month in the previous year expressed as a percentage.
Annual percentage change	The annual percentage change is the change in the index of the relevant month of the current year compared with the index of the same month in the previous year expressed as a percentage.
Average annual inflation rate	The average annual inflation rate is the change in the average specific PPI for all items of one year compared with the average specific PPI for all items of the previous year expressed as a percentage.
Average annual percentage change	The average annual percentage change is the change in the average index of one year compared with the average index of the previous year expressed as a percentage.
Monthly percentage change	The monthly percentage change is the change in the specific PPI of the relevant month compared with the specific PPI of the previous month expressed as a percentage.
Chain linking	The construction of a continuous price series by multiplying together price indices that have been using different weights reference periods. The resulting index is referred to as a chained index (Practical Guide to producing Consumer Price Indices; 2009). Linking is intended to ensure that the individual indices on all levels show the correct development through time, but leads to non-additivity (IMF,2005).
