Key findings as at January 2026

Exports

The unit value index (UVI) for exported commodities shows an annual rate of change of 4,7% in January 2026. From December 2025 to January 2026 the UVI for exported commodities increased by 0,3% – see Table A.

The positive contributors to the annual rate of 4,7% were metal products, machinery and equipment (16,7% and contributing 8,0 percentage points) and beverages (6,4% and contributing 0,5 of a percentage point) – see Table 1 and Figure 4.1.

The main positive contributor to the monthly increase of 0,3% was metal products, machinery and equipment (1,7% and contributing 0,9 of a percentage point) – see Table 1 and Figure 4.2.

Imports

The UVI for imported commodities shows an annual rate of change of -6,7% in January 2026. From December 2025 to January 2026 the UVI for imported commodities decreased by 2,5% – see Table A.

The main contributors to the annual rate of -6,7% were:

- other transportable goods (-8,5% and contributing -3,1 percentage points);
- crude petroleum (-25,6% and contributing -1,5 percentage points); and
- food products (-20,2% and contributing -1,3 percentage points) – see Table 2 and Figure 5.1.

The main contributors to the monthly decrease of 2,5% were other transportable goods (-4,3% and contributing -1,5 percentage points) and metal products, machinery and equipment (-1,0% and contributing -0,5 of a percentage point) – see Table 2 and Figure 5.2.

Figure 2 – Export UVI rates of change (percentage)





Figure 3 – Import UVI rates of change (percentage)

Figure 4.1 – Contributions to the annual percentage change in exports




Figure 4.2 – Contributions to the monthly percentage change in exports



Figure 5.1 – Contributions to the annual percentage change in imports





Figure 5.2 – Contributions to the monthly percentage change in imports



Explanatory notes

Purpose and results	The unit value index provides information on the trends in import and export unit values that are weighted with quantities of the current reference period. The calculation of unit value indices of commodities in exports and imports covers transactions reported by the South African Revenue Service (SARS). The results are used to compile export and import unit value indices, which are a measure of changes in export prices of locally produced commodities and changes in prices of imported commodities. Gold	<p>The export unit value index for gold is calculated from net gold values and quantities obtained quarterly from the South African Reserve Bank (SARB).</p> <p>The index changes quarterly and is published in this publication with a one-quarter lag (e.g. the November 2013 gold value and quantity will only be included in the December 2013 publication).</p>

Glossary

Chain linking	The construction of a continuous price series by multiplying together price indices that have been using different weights for different periods. The resulting index is referred to as a chained index (<i>Practical Guide to Producing Consumer Price Indices, 2009</i>). Linking is intended to ensure that the individual indices on all levels show the correct development through time, but leads to non-additivity (IMF, 2005).
Contributions	The contribution (percentage points) of a sub-index to the percentage change in the total index for a given period is calculated by multiplying the difference (i.e. change) in the sub-index by its weight and then dividing by the previous period's total index. In the case of annual percentage changes, the contributions are approximations owing to annual changes in weights.
Percentage change	The percentage change in an index for any given period is the change between that period's index value and the previous period's index value expressed as a percentage of the latter.

General information
