Preface

This release is compiled and published by Statistics South Africa (Stats SA) according to a framework of International Recommendations for Tourism Statistics 2008 (IRTS 2008) developed by the United Nations World Tourism Organization (UNWTO). The IRTS is one element of a System of Tourism Statistics (STS) that provides information for understanding and monitoring the impact of tourism over time. The other element of the STS for South Africa includes the use of border statistics from the National Department of Home Affairs.

This monthly statistical release provides information on South African residents and foreign travellers who entered or left South Africa in October 2023. Specific focus is on foreign tourists who entered the country in October 2023. Tourists are classified by region and country of residence. Details of their mode of travel; purpose of visit; age and sex distribution are also provided.

The March, June, September and December releases include summaries of number of tourists for the current quarter and comparisons with previous periods.

1. Highlights of the results

In October 2023, 2 648 392 (arrivals, departures and transits) travellers entered and exited South Africa. They were made up of 28,9% South African residents and 71,1% foreign travellers. Foreign arrivals, 1 000 462 were made up of 3,1% non-visitors and 96,9% visitors. The visitors, 969 591 consisted of 24,6% same-day visitors and 75,4% overnight visitors (tourists).

Tourists

Overseas tourists were 26,0% (189 778) of all tourists. United Kingdom (UK) (30 424), USA (28 011) and Germany (27 512) contributed 45,3% to overseas tourists. Southern African Development Community (SADC) tourists were 72,2% (527 616) of all tourists. Zimbabwe (183 692), Mozambique (107 426) and Lesotho (89 226) contributed 72,1% to SADC tourists. 'Other' African countries (non-SADC) tourists were 1,7% (12 495) of all tourists. Kenya (4 464), Nigeria (1 875) and Uganda (1 155) contributed 60,0% to 'other' African tourists. The country of residence of 1 219 (0,2%) tourists was classified as unspecified.

Purpose of visit

'Holiday1' continues to be the main purpose of visit. About 96,4% of all the tourists were in South Africa for holiday purposes.

¹ The holiday category includes tourists who came for vacation, visiting friends and relatives, shopping and other personal reasons such as attending weddings.

2. Key findings

2.1 Travellers

2.1.1 Number of travellers

The routine data collected by the Department of Home Affairs' (DHA) immigration officers at the ports of entry into and out of South Africa shows that a total of 2 648 392 travellers (arrivals, departures, and transits) passed through South African ports of entry/exit in October 2023. As presented in Table 1 below, these travellers were made up of 764 296 South African residents and 1 884 096 foreign travellers. A further breakdown of the figures for South African residents indicates that there were 405 388 arrivals, 358 439 departures and 469 travellers in transit. The corresponding volume for foreign arrivals, departures and travellers in transit was 1 000 462, 846 895 and 36 739, respectively.

A comparison between the movements in September 2023 and October 2023 indicates that the volume of arrivals increased for both South African residents and foreign travellers. The volume of departures decreased for South African residents but increased for foreign travellers. Travellers in transit remained the same for South African residents but decreased for foreign travellers. For South African residents, the volume of arrivals increased by 11,5% (from 363 659 in September 2023 to 405 388 in October 2023) whereas departures decreased by 11,0% (from 402 641 in September 2023 to 358 439 in October 2023). Travellers in transits remained the same at 469 transits. For foreign travellers, arrivals increased by 6,1% (from 943 387 in September 2023 to 1 000 462 in October 2023), departures increased by 4,1% (from 813 196 in September 2023 to 846 895 in October 2023) and transits decreased by 8,3% (from 40 058 in September 2023 to 36 739 in October 2023).

A comparison between the movements in October 2022 and October 2023 indicates that the volume of arrivals, departures and travellers in transit increased for both groups of travellers. For South African residents, the volume of arrivals increased by 15,8% (from 349 974 in October 2022 to 405 388 in October 2023), departures increased by 11,4% (from 321 857 in October 2022 to 358 439 in October 2023) and transits increased by 24,4% (from 377 in October 2022 to 469 in October 2023). For foreign travellers, arrivals increased by 22,6% (from 815 889 in October 2022 to 1 000 462 in October 2023), departures increased by 20,8% (from 700 953 in October 2022 to 846 895 in October 2023) and transits increased by 31,6% (from 27 912 in October 2022 to 36 739 in October 2023).

2.1.2 Mode of travel of travellers

Information presented in Table 2 below shows the number of South African residents and foreign travellers by travel direction and mode of travel. In October 2023, road was the most common mode of travel used by 1 730 259 (65,3%) of the 2 648 392 travellers. Total number of travellers who used air was 913 034 (34,5%). Compared to air and land, a smaller number of travellers, 5 099 (0,2%) used sea into and out of South Africa. Information on arrivals of South African residents shows that 193 368 (47,7%) came by air, 211 811 (52,2%) came by road and 209 (0,1%) arrived by sea. For departures, 163 952 (45,7%) used air, 194 296 (54,2%) used road and 191 (0,1%) left by sea. All travellers in transit, 469 (100,0%) used air.

In the case of foreign travellers, 262 119 (26,2%) arrived by air, 736 078 (73,6%) came by road and 2 265 (0,2%) arrived by sea. When departing South Africa, 256 387 (30,3%) foreign travellers left by air, 588 074 (69,4%) left by road and 2 434 (0,3%) left by sea. All travellers in transit, 36 739 (100,0%) used air.

2.2 Visitors

Detailed information on the departure of travellers is not available in the movement control system. Data on the purpose of travel and the number of days South African residents intend to spend or spent abroad are not collected by the DHA. It is therefore not possible to categorise South African residents as tourists or non-tourists. However, some data are available on foreign arrivals for this categorisation.

As presented in Table 3 on page 4, in October 2023, 30 871 (3,1%) of foreign arrivals were classified as non-visitors, while 969 591 (96,9%) were classified as visitors. Visitors were categorised into three groups:

- i. Arrivals only comprising visitors who entered the country in October 2023 but did not depart in October 2023 [328 794 (33,9%)];
- ii. Single trips visitors who came to South Africa once in October 2023 and left in October 2023 [317 711 (32,8%)]; and
- iii. Multiple trips visitors who came to and left South Africa more than once in October 2023 [323 086 (33,3%)].

Visitors were further grouped as same-day visitors and overnight visitors (tourists). In October 2023, there were 238 483 (24,6%) same-day visitors and 731 108 (75,4%) tourists. Between September 2023 and October 2023, the volume of same-day visitors increased by 1,9% (from 233 986 in September 2023 to 238 483 in October 2023) whereas that of tourists increased by 6,9% (from 684 161 in September 2023 to 731 108 in October 2023). Between October 2022 and October 2023, the volume of same-day visitors increased by 28,6% (from 185 516 in October 2022 to 238 483 in October 2023) and that of tourists increased by 29,2% (from 565 862 in October 2022 to 731 108 in October 2023).

Table 2 on page 3 further shows that of the 238 483 same-day visitors, a majority, 218 236 (91,5%) arrived in the country by road, 20 236 (8,5%) arrived by air and 11 (less than 0,1%) arrived by sea. Information on tourists shows that 498 451 (68,2%) used road, 232 559 (31,8%) came by air and 98 (less than 0,1%) arrived by sea.

2.3 Tourists

2.3.1 Sex and age distribution of tourists

Sex




Figure 1 – Percentage distribution of tourists by region of residence and sex, October 2023

Figure 1 on page 5 shows that there were more male [422 086 (57,7%)] than female [309 022 (42,3%)] tourists. Male tourists constituted the majority of tourists for all three regions, SADC countries [315 247 (59,7%)], overseas countries [98 477 (51,9%)] and 'other' African countries [7 669 (61,4%)]. Similarly, the largest portion of female tourists was from SADC countries [212 369 (40,3%)], followed by overseas countries [91 301 (48,1%)] and 'other' African countries [4 826 (38,6%)].

Age


Figure 2 – Percentage distribution of tourists by region of residence and age, October 2023

The age distribution indicates that out of all tourists, [34 468 (4,7%)] were aged younger than 15 years; [51 701 (7,1%)] were aged between 15 and 24 years; [177 100 (24,2%)] were aged between 25 and 34 years; [216 572 (29,6%)] were aged between 35 and 44 years; [131 823 (18,0%)] were aged between 45 and 54 years; [73 245 (10,0%)] were aged between 55 and 64 years and [46 199 (6,3%)] were aged 65 years and above (see Figure 2 on page 6).

Taking the region of residence into consideration, the results show that the highest proportion of tourists from SADC countries [181 719 (34,4%)] and those from 'other' African countries [4 244 (34,0%)] were aged between 35 and 44 years whereas those from overseas countries [37 053 (19,5%)] were aged between 55 and 64 years. The second highest proportion of tourists from SADC countries [140 225 (26,6%)], those from 'other' African countries [3 102 (24,8%)] and those from overseas countries [33 650 (17,7%)] were aged between 25 and 34 years. The median ages of tourists from overseas, SADC and 'other' African countries were 47, 38 and 39 years, respectively. The proportion of tourists aged younger than 15 years was higher among tourists from overseas countries, 6,6% (12 527) compared to those from SADC countries, 4,1% (21 563) and those from 'other' African countries, 2,9% (366).

2.3.2 Regional and national distribution of tourists

In October 2023, the distribution of overseas tourists was as follows: Europe, 122 599 (64,6%); North America, 33 631 (17,7%); Asia, 17 287 (9,1%); Australasia, 8 446 (4,5%); Central and South America, 4 980 (2,6%) and The Middle East, 2 835 (1,5%).


Figure 3 on page 7 indicates that the 10 leading overseas countries in terms of the number of tourists visiting South Africa in October 2023 were: UK, 30 424 (16,0%); United States of America (USA), 28 011 (14,8%); Germany, 27 512 (14,5%); The Netherlands, 14 417 (7,6%); France, 12 940 (6,8%); Australia, 6 879 (3,6%); Canada, 5 620 (3,0%); India, 5 601 (3,0%); Switzerland, 5 038 (2,7%) and Belgium, 5 017 (2,6%). Tourists from these 10 countries constituted 74,5% of all tourists from overseas countries. A comparison of movements in the 10 leading countries between October 2022 and October 2023 shows that the number of tourists increased for nine of the 10 leading countries. The Netherlands (47,1%) and Canada (46,7%) showed the highest year-on-year increase.

Virtually, most tourists from Africa, 527 616 (97,7%), came from SADC countries. The distribution of the remaining tourists from Africa was as follows: East and Central Africa, 7 629 (1,4%); West Africa, 3 695 (0,7%) and North Africa 1 171 (0,2%). Ten leading SADC countries in terms of the number of tourists visiting South Africa in October 2023 were: Zimbabwe, 183 692 (34,8%); Mozambique, 107 426 (20,4%); Lesotho, 89 226 (16,9%); Eswatini, 65 314 (12,4%); Botswana, 30 680 (5,8%); Namibia, 13 576 (2,6%); Zambia, 13 478 (2,6%); Malawi, 13 144 (2,5%); Tanzania, 3 208 (0,6%) and Angola, 3 124 (0,6%) (see Figure 4 below). Tourists from these 10 countries constituted 99,1% of all tourists from the SADC countries. A comparison of movements in the 10 leading countries between October 2022 and October 2023 shows that the number of tourists increased for nine of the 10 leading countries. Eswatini (48,0%) showed the highest year-on-year increase.




Figure 5 - Number of tourists from the 10 leading 'other' African countries in October 2022 and October 2023

The 10 leading countries in terms of the number of tourists visiting South Africa in October 2023 from 'other' African countries, as shown in Figure 5 below, were: Kenya, 4 464 (35,7%); Nigeria, 1 875 (15,0%); Uganda, 1 155 (9,2%); Ghana, 772 (6,2%); Ethiopia, 724 (5,8%); Egypt, 527 (4,2%); Cameroon, 365 (2,9%); Gabon, 287 (2,3%); Côte d'Ivoire, 209 (1,7%) and Tunisia, 197 (1,6%). Tourists from these 10 countries constituted 84,6% of all tourists from 'other' African countries. A comparison between movements in October 2022 and October 2023 shows that the number of tourists increased for half of the 10 leading countries. Tunisia (123,9%) showed the highest year-on-year increase.

2.3.3 Purpose of visit of tourists

Table 4 on page 9, shows the number of tourists by region and sub-region. Detailed data on the country of residence and purpose of visit is presented in Annexure C on pages 17 to 19. It is observed that in October 2023, the majority of tourists, 704 575 (96,4%), were in South Africa for holiday compared to 22 823 (3,1%); 3 413 (0,5%) and 297 (less than 0,1%) who were in South Africa for business, study and medical treatment respectively.

Within the overseas regions, Australasia, 99,2% (8 382) had the highest proportion of tourists who came for holiday followed by North America 98,2% (33 017); Europe, 98,1% (120 250); Central and South America, 97,4% (4 850); The Middle East, 95,7% (2 714) and Asia, 93,6% (16 175).

Asia, 5,3% (921) had the highest proportion of tourists who came to South Africa for business, followed by The Middle East, 2,8% (78); Central and South America, 2,2% (108); Europe, 1,7% (2 049); North America, 1,6% (543) and Australasia, 0,7% (59).

The Middle East, 1,5% (42) had the highest proportion of tourists who came to study, followed by Asia, 1,1% (184); Central and South America, 0,4% (22); Europe, 0,2% (258); North America, 0,2% (59) and Australasia, 0,1% (5).

Europe (42), North America (12), Asia (7) and The Middle East (1) had less than 0,1% of medical treatment tourists whereas Central and South America and Australasia had none.

Majority of African tourists, 518 047 (95,9%) came to South Africa for holiday. However, the following differences in terms of reasons for travel were observed between tourists from the SADC countries and 'other' African countries, namely:

- Holiday makers constituted 96,1% (506 910) of tourists from SADC countries compared to 89,1% (11 137) from 'other' African countries. Information on the regions of 'other' African countries shows that 90,4% (6 897) of tourists from East and Central Africa were on holiday, followed by tourists from West Africa, 88,0% (3 251) and those from North Africa, 84,5% (989).
- Business persons constituted 3,4% (18 020) of tourists from SADC countries compared to 7,8% (969) from 'other' African countries. North Africa, 12,5% (146) had the highest proportion of tourists who came to South Africa for business purposes, followed by West Africa, 8,1% (300) and East and Central Africa, 6,9% (523).
- Students constituted 0,5% (2 497) of tourists from SADC countries compared with 2,8% (344) from 'other' African countries. West Africa, 3,4% (126) had the highest proportion of tourists who came to South Africa for study purposes, followed by North Africa, 2,6% (31) and East and Central Africa, 2,5% (187).
- Tourists who came for medical treatment constituted less than 0,1% (189) of tourists from SADC countries, while those from 'other' African countries constituted 0,4% (45). West Africa, 0,5% (18) had the highest proportion of tourists who came for medical treatment, followed by North Africa, 0,4% (5) and East and Central Africa, 0,3% (22).



2.3.4 Mode of travel of tourists

Tourists are categorised by their countries of residence and regions. Information on the specific region and country of residence of tourists and the mode of travel used to enter South Africa is provided in Annexure B on pages 14 to 16. As shown in Figure 6 below, 174 828 (92,1%) overseas tourists arrived in the country by air, whilst 14 855 (7,8%) came in by road and 95 (less than 0,1%) arrived by sea. Tourists from the SADC countries, on the other hand, came predominantly by road, 482 322 (91,4%), whilst 45 292 (8,6%) came by air and two (less than 0,1%) arrived by sea. The number of tourists who came into South Africa by air from 'other' African countries was 11 465 (91,8%); while 1 029 (8,2%) used road transport and one (less than 0,1%) used sea.

4. Explanatory notes

4.1 Introduction

Legal movements across South African borders, as well as legal immigration into South Africa, fall under the jurisdiction of the Department of Home Affairs (DHA). Stats SA then processes, analyses and publishes this information.

Administrative data sources from the DHA, that is, information from all the country's ports of entry and applications for permanent residence, constitute the only comprehensive source of information on foreign arrivals and departures, documented immigrants and emigrants. The information from this source of data provides the best national coverage (in terms of both space and time) of the population movements of South African residents and foreign travellers. The data can be used for the following:

- To estimate, monitor and understand salient characteristics of foreign travellers and volumes of South African residents travelling outside South Africa.
- To provide information that can be used to (a) assess the extent of government's progress in strengthening bilateral political and economic relations by assessing the number of international tourist arrivals, and (b) benchmark surveys focusing on the demand for local tourism services by foreign travellers.

4.2 Purpose of the statistical release

This release reports on arrivals, departures and transit travellers of South African residents and foreign travellers. Detailed information on the age and sex distribution; mode of travel; national and regional distribution; and purpose of travel of overnight visitors or tourists are also provided.

4.3 Scope and coverage

The release covers data collected by DHA officials on travellers who departed from or entered the Republic of South Africa (RSA).

4.4 Data

Information published in this release is based on data obtained from the following data sources within the DHA:

- Data routinely collected by immigration officers at all road, air and sea entry ports on all travellers (South African residents and foreign travellers) arriving into or departing from South Africa are captured into the DHA's population Movement Control System (MCS). The counts/statistics relate to the number of individual movements, rather than to the number of people. Hence, the multiple movements of individual people during the calendar month are each counted separately. Generally, the data are collected directly from travel documents either by scanning or capturing onto the ports' electronic database. No forms or cards are used (except on rare occasions when the capturing system is down) to collect information from travellers. Individual ports regularly transmit data onto the national database at the head office of the DHA.
- Stats SA receives downloaded data covering a particular calendar month from the DHA.
- As part of data interrogation, data from OR Tambo International Airport, which has the highest volume of travellers, are compared with passenger statistics from the Airports Company of South Africa (ACSA). As expected, in any specific month, an increase in the volume of passengers reported by ACSA is also reflected in an increase in the volume of travellers recorded by DHA. A similar pattern has also been observed when the volume of travellers decreased. In October 2023, the DHA data was 2,7% lower than that of ACSA.

4.5 Limitations

4.5.1 Outbound tourists

The information on the total number of arrivals and departures of South African residents is collected from the scanning of passports. However, data on the country visited are not collected from passengers; country of final destination; intended duration of stay and purpose of visit. With this limitation, it is impossible to identify the number of tourists from the data on South African residents.

4.6 Definition of terms

4.6.1 Definitions used by the United Nations World Tourism Organization (UNWTO)

Traveller is someone who moves between different geographical locations for any purpose and any duration.

Visitor refers to any person travelling to a place other than that of his/her usual environment for less than 12 months and whose main purpose of the trip is other than the exercise of an activity remunerated from within the place visited.

Same-Day visitor is a visitor who visits a place for less than one night.

Tourist (overnight visitor) is a visitor who stays at least one night in collective or private accommodation in the place visited.

Tourism comprises the activities of persons travelling to, and staying in places outside their usual environment, for not more than one consecutive year, for leisure, business and other purposes. The usual environment of a person consists of a certain area around his/her place of residence, plus all the other places he/she frequently visits.

4.6.2 Definitions used specifically in this release

South African resident refers to either a South African citizen or a non-South African citizen with a South African permanent residence permit.

Foreign traveller refers to a traveller who is not a South African citizen or permanent resident.

Region refers to the following country classification:

- Overseas: Europe, North America, Central and South America, Australasia, the Middle East and Asia.
- Africa: SADC and 'other' Africa (East and Central Africa, West Africa and North Africa).

Country refers to individual countries within a region. The country of residence is used. The country of residence should not be confused with the country from which the visitor travelled.

Africa refers to all the countries in Africa (both mainland and island countries).

SADC refers to the 14 countries, excluding South Africa, which belong to the Southern African Development Community.

'Other' African refers to all non-SADC African countries.

Overseas refers to all countries outside Africa.

Trip refers to the arrival and departure of a visitor in a specified month.
