PREFACE

This report contains migration statistics (documented immigration and self-declared emigration) for South Africa (SA).

The information in this report was obtained from the following source documents of the Department of Home Affairs (DHA):

- Form BI-55 filled in by immigrants on their arrival in SA and Form BI-117 filled in by emigrants on their departure from either Johannesburg, Cape Town or Durban International Airports; and
- Forms BI-807 and BI-834 concerning persons, who, after their arrival as visitors, were approved as immigrants by the DHA.

The report shows the number of documented immigrants and self-declared emigrants and the net gain/loss to the population of SA. It also contains some information on migrants, such as age, occupation and mode of travel. For documented immigrants there is additional information on country of previous permanent residence, country of birth, country of citizenship and for self-declared emigrants there is additional information on destination country and occupation.

Migration statistics are also published in the quarterly *Bulletin of Statistics* and in the monthly Statistical release P0351: *Tourism and Migration*.

SUMMARY

Introduction

This report presents data on declared permanent immigration to, and permanent emigration from, South Africa (SA) during 2003. While there are several sources of emigration statistics, at present Statistics South Africa obtains its emigration statistics from the departure forms filled in by South African residents upon departure from either of the three international airports of Johannesburg, Durban and Cape Town. By law it is compulsory for South African citizens to fill in these forms. However, for various logistical reasons it is not always feasible to accurately verify the contents of the details filled in. In other words, an intending emigrant may not always fill in the form, and even if the intending emigrant does complete it, he/she may state that the purpose of visit is 'holiday' or 'business'. The emigration statistics reported here, therefore, refer to 'self-declared emigration', which is different from actual emigration. A comparative assessment of the data on self-declared emigration is given in the section following the summary. The possibility of obtaining and analysing different sources of migration data is being explored. Readers will be informed of any progress in this regard.

Historical trend in documented immigration and self-declared emigration

Trend in documented immigration to SA

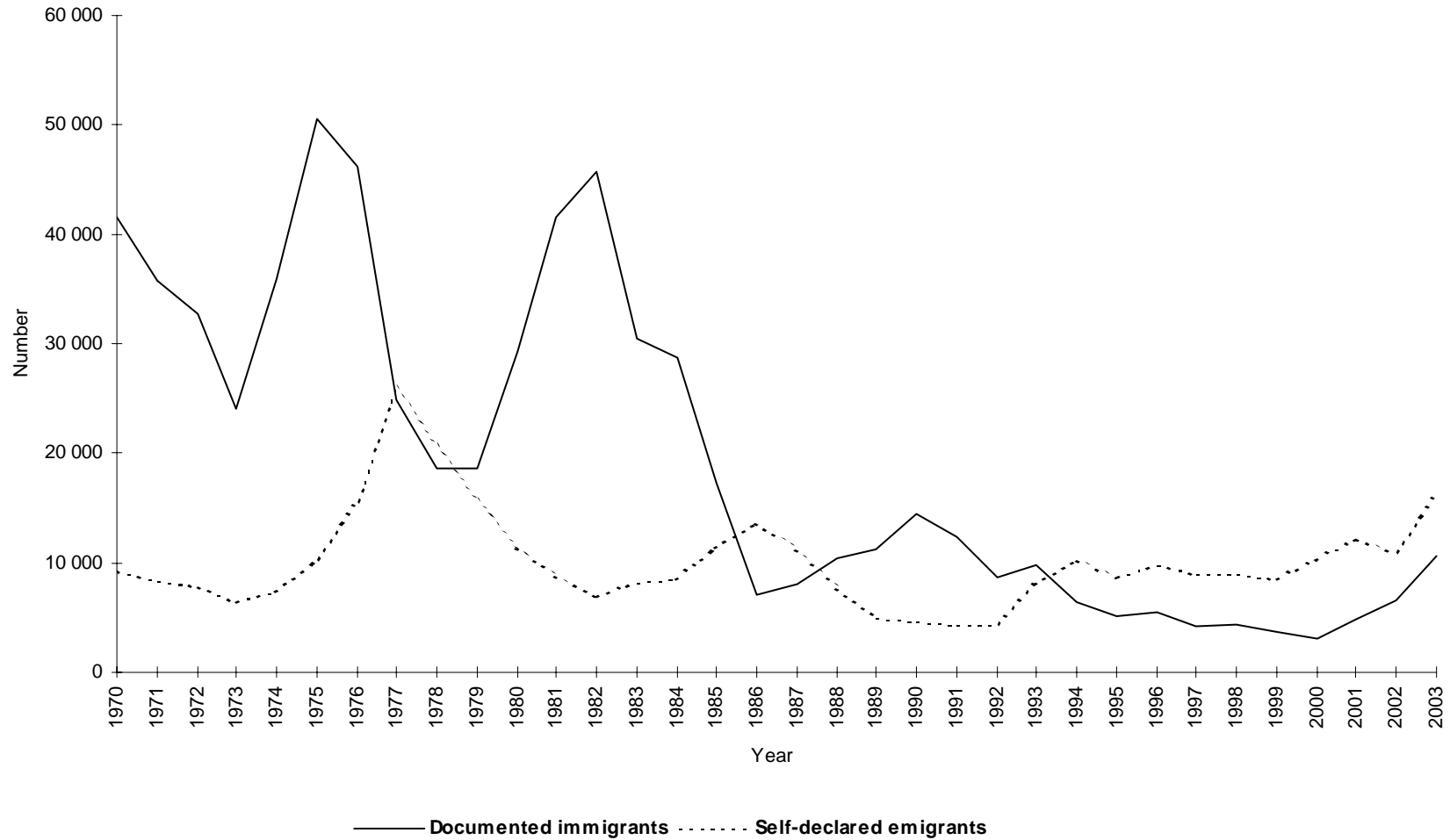
Fig. 1: Documented immigrants and self-declared emigrants, 1970-2003

There have been wide fluctuations in the trends of documented immigration to SA. Figure 1 shows that there were two prominent peaks. One peak occurred in 1975 and the other in 1982. The 1975 peak was largely due to the doubling in the number of immigrants from the UK between 1973 and 1975 and to some extent, immigration into SA from Mozambique after the country gained independence in that year. The 1982 peak was largely due to immigration to SA from the UK, China and Portugal. From 1990 onwards there was a downward trend in the number of documented immigrants to SA until 2001 when the trend started picking up. In 2003 the number of documented immigrants to SA was 10 578, an increase of 61,6% as compared to the 2002 figure of 6 545.

Trend in self-declared emigration from SA

The emigration data from 1970 to present show three major peaks. These peaks occurred in 1977, 1986 and 1994. During those peak years the leading destination country for self-declared emigrants was the UK. In the post-1994 period the trend in self-declared emigration from SA to other countries has been gradual. In 2003 the number of self-declared emigrants turned out to be 48,4% higher than that of 2002. The number of self-declared emigrants increased from 10 890 in 2002 to 16 165 in 2003.

Documented immigration and self-declared emigration by country of origin and destination, respectively

As stated earlier, the total number of self-declared emigrants from SA during 2003 was 16 165. Of these, 12 710 (78,6%) were South African citizens. The rest were permanent residents who were either returning to their countries of origin, or emigrating to other countries after having settled in SA for a while.

Figure 2 shows the distribution of the leading source countries (of previous permanent residence) of documented immigrants and leading destination countries of self-declared emigrants. During 2003 Nigeria was the leading source country of documented immigrants and the UK the leading destination country of self-declared emigrants. A total of 1 698 documented immigrants (16,1%) from Nigeria came to settle in SA and a total of 5 204 self-declared emigrants (32,2%) went to settle in the UK. Other leading source countries of documented immigrants were: the UK, 1 032 (9,8%); Zimbabwe, 959 (9,1%); Pakistan, 645 (6,1%); China, 561 (5,3%); India, 551 (5,2%) and Germany, 365 (3,5%). Other leading destination countries of self-declared emigrants were: Australia, 2 276 (14,1%); the USA, 1 598 (9,9%); New Zealand, 966 (6,0%); Namibia, 617 (3,8%) and Canada, 400 (2,5%).

Documented immigrants by country of previous permanent residence, country of birth and country of citizenship

For a person who has been granted permanent residence status in SA, details are collected about the person's country of birth, the country of citizenship and the country of previous permanent residence. If for any given country more immigrants report that country as their country of birth than their country of citizenship, this may reflect the emigration of second generation immigrants of that country. If for another given country more immigrants report that given country as their country of previous permanent residence than their country of birth, this may reflect a step-wise migration process for short-term immigrants of that country. In effect, this refers to persons who emigrate from their home countries to another country where they stay for a while until they obtain permanent residence in that country and subsequently emigrate from there. Lastly, if for yet another given country, more immigrants report that country as their country of citizenship than their country of birth, this may reflect a step-wise migration process for long-term immigrants of that country. This also refers to persons who emigrate from their home countries to another country where they stay till they obtain citizenship and then emigrate further from there.

During 2003 a total of 10 578 persons were granted permanent residence in SA. Of these 2 827 (26,7%) were granted residence before arrival and 7 751 (73,3%) after arrival. Of the total number granted permanent residence 5 596 (52,9%) were permanent residents of an overseas country and 4 961 (46,9%) were permanent residents of a mainland African country. Of the immigrants from overseas the number reporting such a country as their country of birth (5 593) is about the same as those reporting such a country as their country of previous permanent residence (5 596). Of the immigrants from mainland Africa the number reporting a mainland Africa as the country of birth (4 984) is about the same as those reporting such a country as the previous permanent residence (4 961).

Slightly more immigrants reported an overseas country of citizenship (5 690) than their country of birth (5 593). This means that immigration to SA from overseas comprises not only born-citizens of overseas countries, but also naturalised citizens of those countries. On the contrary, slightly more immigrants reported a mainland African country as their country of birth (4 984) than their country of citizenship (4 886). This means that immigration to SA includes not only citizens of those countries but also second-generation immigrants into those countries.

Selected characteristics of documented immigrants and self-declared emigrants

Age and occupation are two important characteristics of documented immigrants and self-declared emigrants. These two important characteristics have an impact on the labour force and its composition.

Age profile of documented immigrants and self-declared emigrants

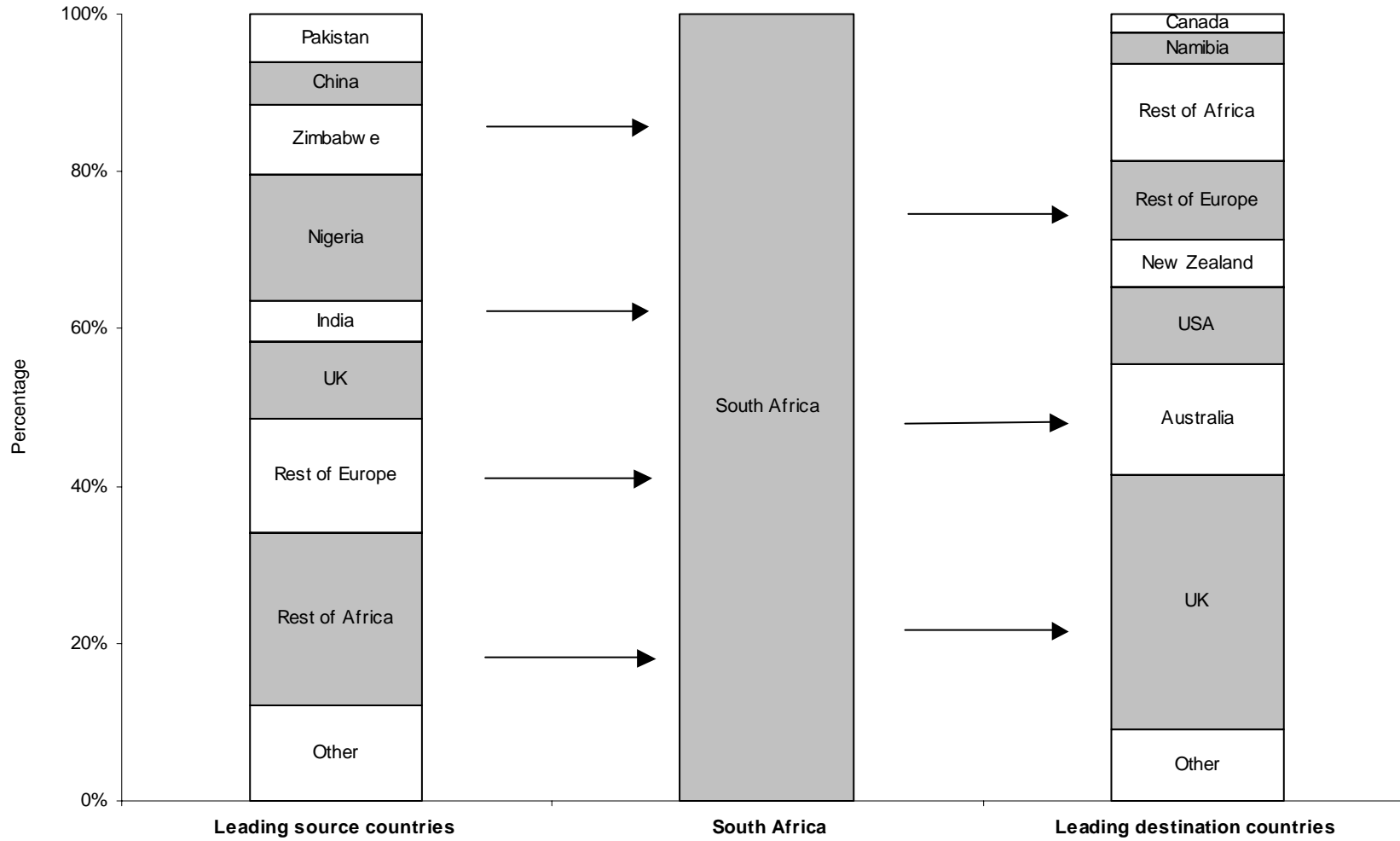


Fig. 3: Percentage distribution of documented immigrants and self-declared emigrants by age group, 2003

The percentage distribution of both documented immigrants and self-declared emigrants by age group in 2003 is shown in Figure 3. Both age profiles show a major peak as in standard age profiles of migration. For self-declared emigrants, the peak is broad and occurs over the age range 25-34. For documented immigrants, the peak occurs over the age group 30-34. For documented immigrants a minor peak occurs at the age group 5-9, reflecting the phenomenon of young dependant children accompanying their migrating parents. For ages below five to 29 and ages 40 to 59, there is relatively higher proportion of self-declared emigrants than documented immigrants, while for ages between 30 to 44 and 60 and over, there is relatively higher proportion of documented immigrants than self-declared emigrants.

Occupation background of documented immigrants and self-declared emigrants

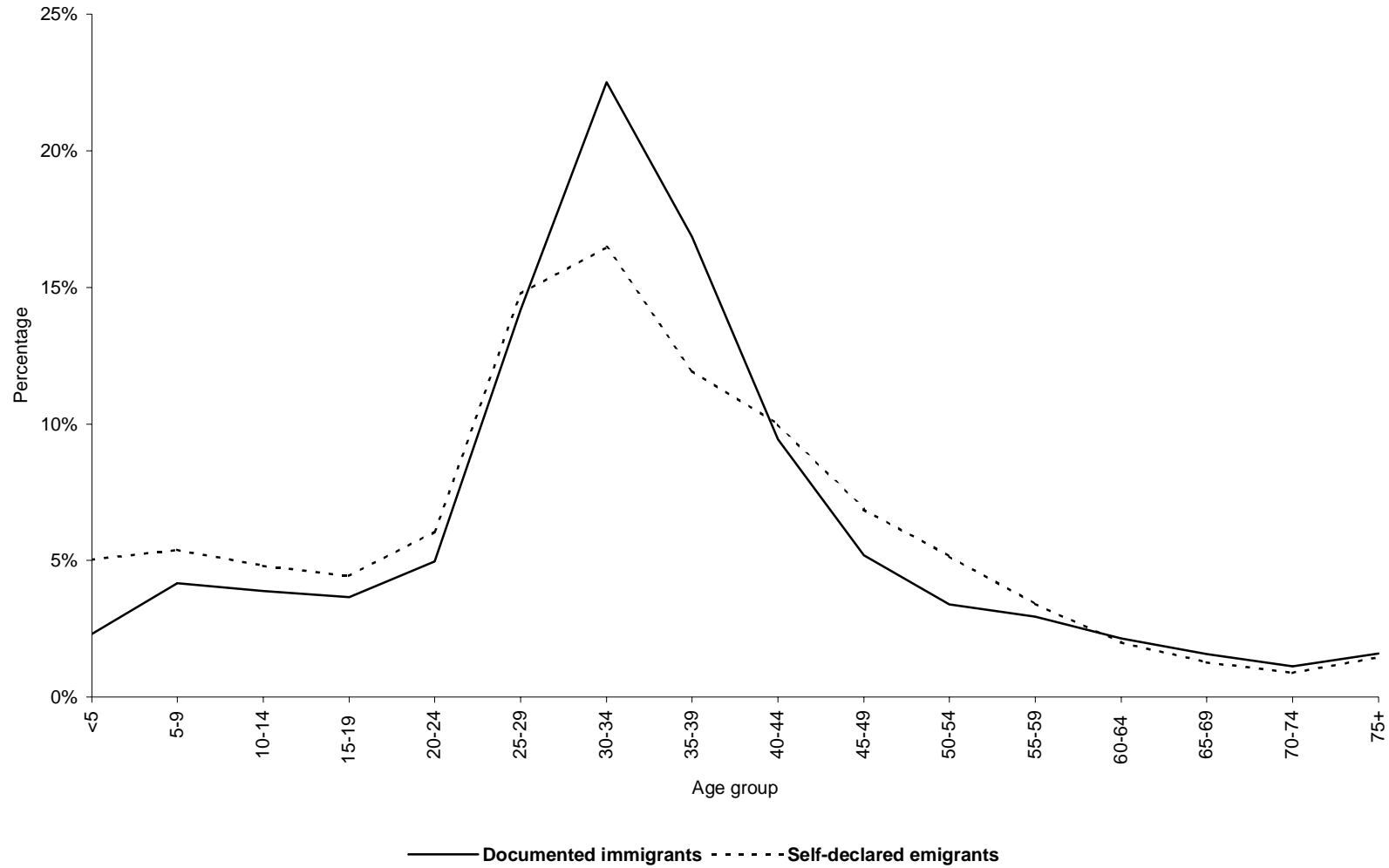
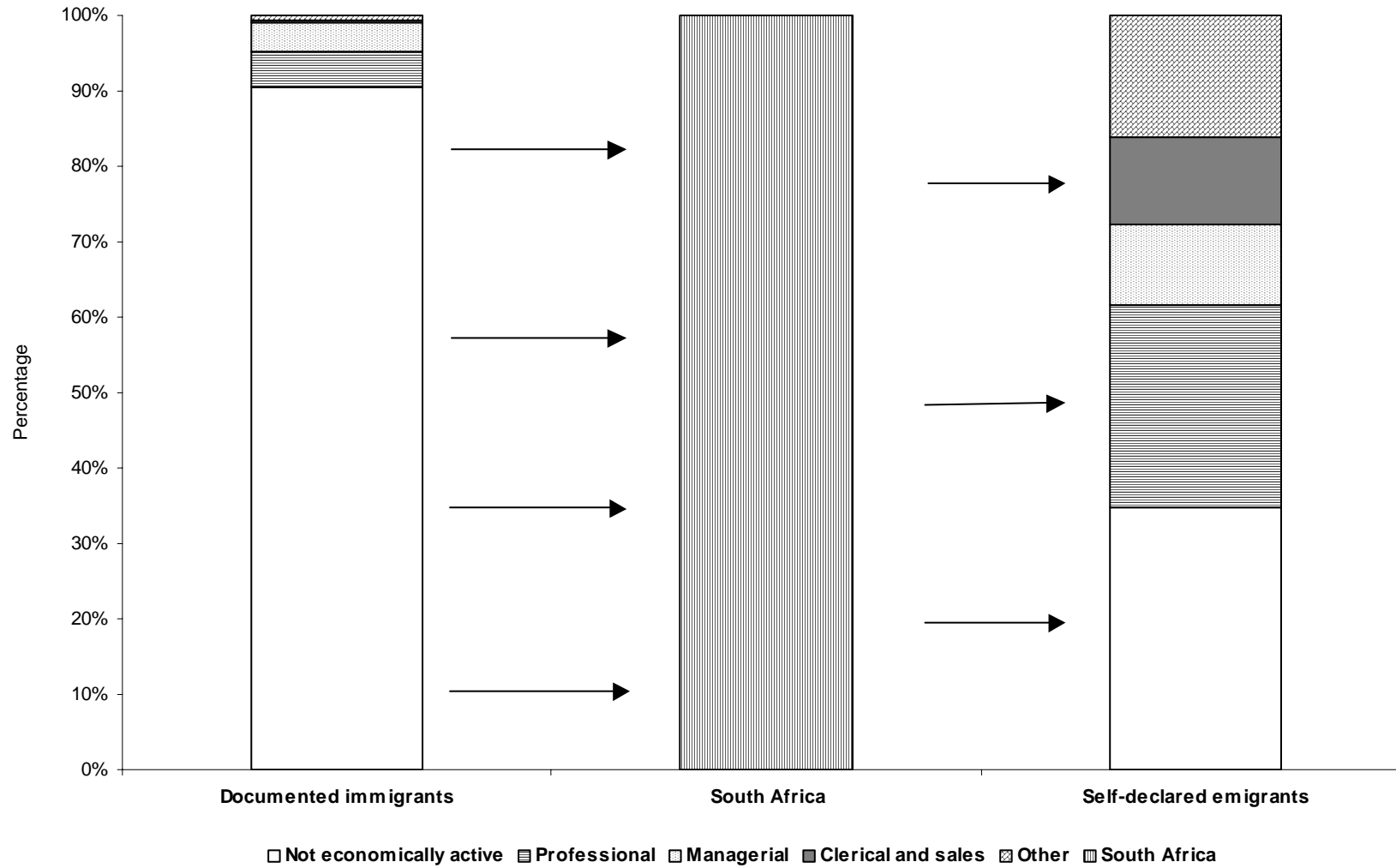


Fig. 4: Percentage distribution of documented immigrants to South Africa and self-declared emigrants from South Africa by occupational category, 2003

During 2003 out of the 10 578 persons granted permanent immigration status, 1 011 (9,6%) were economically active, while 9 567 (90,4%) were not economically active. For self-declared emigrants out of a total of 16 165, 10 540 (65,2%) were economically active, while 5 625 (34,8%) were not economically active. Of the economically active documented immigrants 499 (4,7%) were in the professional category, followed by 416 (3,9%) in the managerial category. On the other hand, 4 316 (26,7%) of the economically active self-declared emigrants were in the professional category, followed by 1 895 (11,7%) in the clerical and sales category. Figure 4 shows this occupational breakdown among both the documented immigrants and the self-declared emigrants.

Fig. 2: Leading countries of documented immigration to South Africa and leading countries of self-declared emigration from South Africa, 2003

COMPARATIVE ASSESSMENT OF DATA ON SELF-DECLARED EMIGRATION, 2002 UPDATE

Introduction

Over the years official statistics on self-declared emigration from SA show that the five leading overseas destination countries are the UK, USA, Canada, Australia and New Zealand. As these countries have good statistical systems, in principle, it would be possible to obtain data on South African residents and/or South African citizens who have permanently settled in these countries. The figures obtained from those sources could be compared with official figures on self-declared emigration and the degree of under-reporting of emigration could be assessed.

Methods used

In the situation where there is a lot of missing data, the comparison of emigration data from a sending country with the immigration data in the receiving country is not a straightforward exercise. Handling of missing data involves having a critical look at the data and making discretionary judgements in the appropriate method to apply. While limited data are available on both flow and stock statistics in the receiving countries, this section only reports on the stock data (actual and estimated) in the receiving countries and how they have been used in the comparative assessment.

In a situation where there are three or more data points, a simple regression equation is fitted on these points. The equation is used to estimate the South African resident population at different dates. In the case of Canada, data are available at three census dates, while in the case of Australia, the Australian Bureau of Statistics (ABS) estimates of the resident population are available at eight dates. For the dates for which data are available, the regression estimates were replaced by the available data (written in bold in Table D).

In the case where there are two data points, simple linear interpolation was used to obtain the figure for each year of the intervening period. This was the case with New Zealand and Great Britain.

Data collated from responses received

Some of the data received from the different statistical and migration organisations have been summarised in Tables A, B and C. The data pertain to the five leading overseas destination countries mentioned earlier.

Findings

In Table D the flow statistics from SA were cumulated to make them comparable to the stock statistics from the receiving countries. What the table shows is that for the USA, Australia and New Zealand, the estimated number of resident immigrants from SA far exceed the Stats SA estimate of total emigrants to those countries. The Table shows that by 1995 the difference was little over 40 000 for the USA and close to 22 000 for Australia by 1998. The official statistics on emigration from SA to the five leading destination countries come to 205 022 over the period 1970-2001. However, from the perspective of the receiving countries, the total number of South African citizens/residents who have immigrated to those countries was 322 499 by 2001. This makes Stats SA figures to be a 57,3% under-estimate of the independently estimated figures. During the period 1970-2001, a total of 275 019 emigrated from SA to other countries as reported by Stats SA. If the under-estimate is applied to this figure, then one would estimate that a total of 392 496 South African citizens/residents left the country between 1970 and 2001. This is an estimate and would be further refined as more data become available.

It must be noted that the sources of data in the receiving countries are not all 100% accurate. Most weight should be given to the census data in those countries. The census data would capture all those emigrants from SA who had not yet been granted immigration status. The census data will also take account of mortality. There is, however, the slight danger that in the event of step-wise migration, meaning that the emigrant from SA had emigrated to that country from a country other than SA, the flow and stock data will not be strictly comparable. Lastly, it must be noted that most emigration are event-triggered and do not necessary rise or fall in a smooth manner.

Way forward

The communications that have been established with overseas statistical organisations should be maintained. The calculations presented here should be updated, as more stock and flow data on emigration/immigration become available. Attempts must be made to obtain data on other independent sources of emigration data. These would complement the data on self-declared emigration and give a more complete picture of emigration from SA.

EXPLANATORY NOTES

1. Background

1.1 Data collection instruments

Legal movements across South African borders as well as legal immigration into South Africa (SA) fall under the jurisdiction of the Department of Home Affairs (DHA). At present, data on migration are obtained from the departure forms and the administrative records relating to the granting of permanent residence in SA. For South African residents, data on temporary departures are obtained from scanning of the bar codes in the passport (upon departure and upon return) and the departure forms. The filling-in of departure forms used to be done at all ports of entry but from 26 November 1993, this system is only implemented at the three international airports of Johannesburg, Cape Town and Durban. For South African residents emigrating from SA, the information is obtained from the same departure form when the resident states that he/she is emigrating. Lastly, administrative records are kept for all non-South African residents who have been granted permanent residence status (either before arrival or after arrival).

1.2 Compilation of migration statistics

For South African residents the same departure forms (filled in at the three international airports) are used to obtain information on emigration from SA. When the data are captured at Stats SA, self-declared emigrants are separated from temporary departures. For the moment, the departure forms they fill in provide the only source of information for purpose of visit and country of destination. The forms are sent to Stats SA on a weekly basis for data capturing and processing. It must be noted that the filling-in of the departure forms is not strictly enforced, hence the statistics on the actual number of South African residents who depart temporarily, is obtained from the data based on the scanning of the bar codes in the passports.

For non-South African residents, information on legal immigration into SA is compiled by DHA from administrative records and captured on the computer. A printout of this data is sent to Stats SA where the information is coded and captured by clerical staff.

2. Assessment of statistics on self-declared emigration

2.1 Overview

In comparing the data from the sending country (SA) and the receiving countries, one encounters the classic problem of flow versus stock data. The sending country only has (incomplete) flow data (persons leaving during the year) while the receiving country may (in

principle) have both flow and stock data. Strictly, it is best to compare flow data of one country with flow data of the other country. In a few cases it is possible to obtain flow data from stock data (as in the case when questions on migration history are asked in a census or survey).

With regards to stock data, the closest comparison that can be made is between the census data in the receiving country and the cumulative flow data from the sending country. If both sets of statistics are complete the cumulative flow data up to a certain (census) data should be greater than the figures obtained from the census data. The reason for this is that the census data in the receiving country pertain to survivors of the original number of immigrants coming from the sending country.

2.2 External sources of data

2.2.1 Great Britain (England, Wales and Scotland)/UK

The Office of National Statistics (ONS) conducts census and surveys. The latest census was conducted in 2001 and covered Great Britain. The census has information on country of birth of respondents and hence can give stock information on South African born persons living in GB. The ONS also conducts the Labour Force Survey in which questions are asked about date of arrival to the UK. That breakdown could yield flow statistics. Another section of ONS compiles international migration data from the International Passenger Survey (IPS). The IPS is a continuous voluntary survey, which has been running from 1964. The survey collects data on those passengers (through all air and sea routes) who have lived abroad for at least 12 months and intend to reside in the UK for at least 12 months. As the IPS is a survey, it produces estimates of immigrants, not exact counts. In this section only the census data and the data from the Labour Force Survey have been used.

2.2.2 The USA

In the USA, there is the Immigration and Naturalization Service (INS) at the US Department of Justice. The INS publishes a yearbook in which flow statistics are provided on immigrants to the USA and their countries of birth. The INS also publishes an annual report on legal immigration to the USA. The US Census Bureau is the main source of stock statistics on foreign-born population data. They compile their data from the decennial censuses and the Current Population Survey (CPS). Using these data, they do population projections to estimate the number of foreign-born residents in the USA.

2.2.3 New Zealand

In New Zealand, Statistics New Zealand is the main source of both stock and flow statistics that yield migration statistics. Statistics New Zealand conducts a census after every five years from which they provide stock statistics on foreign residents and their countries of birth. The last two censuses were held in 1996 and 2001. Statistics New Zealand also publishes monthly and yearly flow statistics on 'permanent and long term arrivals'. The 2001 census figures were updated with the latest available flow statistics to yield post-1996 estimates.

2.2.4 Australia

In Australia, the Australian Bureau of Statistics (ABS) is the main source of both stock and flow statistics that yield migration statistics. The ABS conducts a census after every five years from which they provide stock statistics on foreign residents and their countries of birth. The last two censuses were held in 1996 and 2001. The ABS also publishes monthly and yearly flow statistics on 'settler arrivals' and publishes estimates of the resident population by country of birth. The immigration and emigration statistics published by the ABS are obtained from data collected by the statistics section of the Department of Immigration and Multicultural Affairs (DIMA). The data are based on information from completed arrival and departure passenger cards and supplemented from passport and visa information. In this comparative assessment, the ABS estimates of the resident population (available at eight dates) were used.

2.2.5 Canada

In Canada, Statistics Canada conducts a census after every five years from which they provide stock statistics on foreign-born population residents in Canada. In the comparative assessment, the census data (available at three dates) were used. In addition, flow statistics on South African citizens granted permanent residence in Canada are published annually by the Department of Citizenship and Immigration Canada. The 2001 census figures were updated with the latest available flow statistics to yield post-1996 estimates.

3. Definitions

- 3.1 **Documented immigrants** refer to residents of other countries who have been accepted as permanent residents in South Africa. The permanent residence status could be given either before or after arrival in South Africa.
- 3.2 **Self-declared emigrants** refer to South African residents who, at the time of departing from South Africa, state their intention to leave the country and reside permanently elsewhere.

4. Classifications used

- 4.1 For occupations, the occupational classification used is based on the *Standard Classification of Occupations, First Edition, 1986* Report No. 09-90-01,.
- 4.2 Geographical classification of countries was based on the list used by DHA.

5. Abbreviations and symbols
